#### Supreme Court Decisions.

The State Supreme Court has just handed down two decisions which are of interest to some of our people. The first was that in the case of John Campbell Brice, appellant, vs. R. W. G. Cayce and James Cayce. In this case the judgment of the lower court was affirmed. second was that of Elizabeth E. Haltiwanger, as administratrix, respondent, vs. the Columbia, Newberry and Laurens railroad company appellant. This was an action to recover \$7,000 damages occasioned by the killing of plaintiff's husband, a verd ct of \$1,750 for the plaintiff was given by the lower court. The Supreme court has set aside this verdict and granted a new trial.

#### High Winds and Deep Thunder.

Thursday night witnessed the severest wind, rain and thunder storm that has visited this place in years. The wind was at times, terrific, reaching a velocity of forty-five or fifty miles an hour, and the bottom of the clouds seemed to have dropped out losing their accumulation of waters and it looked as if the world was again to be submerged in the deluge of a flood. The thunder was rumbling, deep toned and angry and the lightning was vivid and sharp, but the warring elements quieted down and a peaceful calm followed the disturbance. No damage to life or property has been reported, but many citizens were greatly alarmed and walked the floor in fear and prayer during the prevalence of the storm.

#### Court Adjourned.

When we went to press last week the trial was in progress in the case of D. T. Here vs. Thos. H. Caughman, Sheriff. An action for "claim and delivery." The verdict, which was in favor of the plaintiff, was rendered Thursday morning.

In the case of Henry A. Meetze vs. Jesse K. Dooley, trespass to try title, the verdict was in favor of plaintiff with \$150 00 damages.

The case of J. C. Fort vs. Southern Railway Company, after the jury was empanelled, was non suited. This case was brought by Messrs. Graham and Nelson, and damages in the sum of \$1500 00 were asked. Mr. Fort was a passenger on a Southern train from Pelion in June, last year, and when the train reached Cayce, the crew and engine returned to Perry, leaving the passengers at Cayce. Mr. Fort was compelled to walk from there to Columbia, as he alleges, and for these and the other facts set out, he asks for above dam. ages. Mr. E. M. Thomson was counsel for the corporation.

The case of H. B. Senterfiet and others vs. Amanda Shealy and others, brought by Messrs. B. W. Crouch and Efird & Dreher, came up Friday and Saturday. Messrs. Graham and Strother represented the defendants. This was an action to recover possession of one hundred acres of land near Batesburg, but the verdict was adverse to the recovery. Judge Buchanan ordered the verdict set aside and granted a new trial.

Upon the call of the calendar for the third week, only one case was announced for trial, and after the the jurors were empanelled for it, the others were discharged.

The case tried was W. H. Gibbes & Co. vs. J. Marshall Shealy, brought by Messrs. Thomas & Gibbes of Columbia. Messrs. Muller & Sturkie appeared for the defendant. The case came to an end yesterday afternoon, when the Judge called the jury out of the room and ordered a mistrial. They failed to agree. It is stated that the jury was evenly


