The aged father of Solicitor Thurmond recently died.

It looks very much like a Parker wave has swept the State.

Congress has adjourned and its members have gone home to look after their political fences.

Senator B. R Tillman goes to the State convention from Edgefield and it is hoped his throat will allow his voice to be heard.

The situation at Port Arthur remains unchanged. The Russians are still "holding the fort," and the Japanese have been unsuccessful in their attempts to blockade the barbor.

The county conventions held throughout the State show that the State is for Parker, and the State convention will be almost unanimous for his nomination for President.

Judge Jater C. Prichard, Republican, former United States Senator f om North Caroline, has been appointed Judge of the 4th Circuit of the United States Court to succeed the late Judge Simonton.

Mr. S. G. Mayfield has withdrawn from the Congressional race in the second district, leaving an open field for Mr. T. G. Croft. The second primary to fill the unexpired term of the late Hon. G. W. Croft will be held next Saturday.

The gates of St. Louis' big show were formerly thrown open to the world on April 30 On the stroke of 1 President Rosevelt, in Washington, touched the button and the big wheels in St. Louis immediately began to revolve.

The whole situation in the far East can be summed in this way. Russia is afraid of Japan and Japan is glad of it. The war correspondents spend all day in writing graphic accounts of imaginary battles on land and sea, and then the next day is denying the whole account in to-to, and so it goes. The poor fellows must do something to earn their wages.

Judge Charles H. Simonton passed from earth into that great unknown country on the morning of April 26 He had been in declining health for some years, and about five weeks ago he became a patient in the Orthopaedes hospital in Philadelphia, where he was treated for nervous trouble. For a number of years Judge Simonton was prominent in State politics. He was appointed court, by President Cleveland, and was elevated by the same President to Circuit Judgeship which he held nutil the day of his death.
