## LAW AS TO CANDIDATES．

 Candidates Must Now File Pledge and Swear to Itemized Statement of Campaign ExpensesThe following act passed by the legiefature will be of interest to all， eapecially candidates．Every man Who runs for oflce mut comply with its provieions．
Section 1．At or before every poli tical primary election，held by any municipal party，organization or as candidates for cffice of the election delegates to consentions in this State any person who shall by threats or any other form of intimidation o promise of mones，any other article of Value，procure or ffar，promise or of value，procure or ofler，promise ot for or againat any particular candi－ date in such election or who shall fo any such consideration，ofrer shall be guilty of a misde．

Sec． 2 Every candidate cffering frr election，under the provisions of section 1 ，ehall make the following pledge and file the fane with the clerk of tbe court of common pleas
for the county in which he is a can－ didate，unless be should be a candi－ date in more tban one county，in Which case te shall file same with enter upon bis campaign to wit，I the undersigned－，of the county cadidate for the office of－here wr pate fore b；pledge that I will not give nor
epsod money，or uae intoxicating spand mones，or uas intosicating
liquors for the purpose of obtaining or influencing votes，and that I sba at the conclusion of the campaign ard before the primary election render t the clerk of the court（or secretary（ State as hereinbefore provide（），tn der oath，an itemized statement of al moneys epent or provided by me dur ing the campaign for campaign pur poses up to that ine，and I further pledge that 1 will immediately afte the primary election or elections tha I am a cabliaste in，render an item ized statewes，uder oath，slowing all further moneys epent or provided by me in kaid election．Provided that a failure to comply with thi null and void in so far as the candi da：e who fails to file the statement herein rtquired，but sball not $\varepsilon f f=c$ the valiaity of the election of an candidate complying with this sec tiou．Avd provided fach itemized statement and pledge shall be open to public in all times．
Sec 3 That eny violstion of the provisious of the act shall be a mis
demesnor，and any person upon con－ viction thereof，shall be fined not les than $\$ 100$ nor more than $\$ 500$ or be imprisoned at hard labor for not less
than one month nor more than six montbs，or bath fine and imprison
