Senator Tillman's bill to define and suppress vagrancy specifed in
detail the persons who shall be con sidered vagrants. It includes all idele and immoral persons and those lead
ing a profigate life, ide persons who ing a prolizate Me,
hate o visibe means of suport, per
sons who frequent evil resorts, per sons wandering abroad and begging and varions others. The bill provide that every person who is convicted
of vagrancy shall be put under a $\$ 50$ of for for his' good behazior for one year. Violation of the conditions of the bond will be punished by sentence to the work house for a period not to exceed one year.
