

Shot by Young Girl.

Tunica, Miss., June 12.-Seeking revenge for the death of her father, Percy M. Houston, who was shot to death on the streets of this city hardly two months ago, Mrs. Jacob Weinstein walked up behind his slayer, J. T. Lowe, a prominent attorney, on the principal street of the town yesterday morning, and fired point blank into his back. A second shot, which was meant for Lowe, was deflected by her ten-year-old brother-in-law, who was accompanying her, and who grasped her arm after the first discharge of the revolver.

Thinking his assailant was a man Lowe wheeled to defend himself, and pulled his pistol as he turned. He saw a woman before him.

"Oh, you are a lady! I will not shoot you!" and the desperately wounded man quietly placed the weapon in his pocket and walked to a physician's office, where he collappsed. Mrs. Weinstein fled to the home of her mother, where she is now in custody of a deputy.


