Mob Lynchs White Man.

Forcing their way into the Desha County jail at Dumas, Ark., between fifty and one hundred men, members of a mob formed so quietly that the authorities had not the slightest warning, overpowered the deputies in charge and took Charles Malpas, Sr., white, to a water tank and hanged him early Wednesday. The mob then dispersed without demonstration.

The lynching followed a pitched battle at the home of Malpas the day before, in which the sheriff and two deputies were killed. The wife of Charles Malpas, Sr., a negress, and the Malpas younger son, a young mulatto, escaped from the house during the fighting. The authorities say they do not think the negress and the boy engaged in the battle and for this reason it is not thought the two will be sought further in connection with the affair.

A Bloodthirsty Virginian.

In the presence of a large crowd of people, who had assembled for court week at Lovingson, Va., Dr. J. A. An ancient grudge is said to have been responsible for the tragedy. The shooting took place on one of the principal streets of the town in front of the hotel. There was no quarrel at the time of the shooting.

Georgia Expressman Destroys Money.

A special from Waycross, Ga., of recent date says:

Hundred dollar bills, fifties and other smaller denominations were torn into shreds and silver coins by the bag full were scattered about an express car today by C. F. Radford, express messenger on the Atlantic Coast Line train No. 21, before he was finally subdued and landed in jail here.

Radford claimed he insisted in Savannah that he should not be sent out on the run because of his condition, that he was intoxicated and did not know what he was doing in throwing away the money from the safe.

The loss, if any, will not be known until the money packages are carefully checked. Between \$3,000 and \$10,000 was on board and most of this amount was recovered from Radford's bosom and trousers pockets, according to the officers.
