#### **Bloody Battle** Waged at Windsor

Aiken, March 10.—Windsor, in this county, was the scene of a bloody battle last night, in which Hanford Cushman was killed and three others were severely wounded by the town officers, and John Cleckley, chief of police, sustained more or less serious injuries.
Cleckley and his assistant, L. B

Johnson, are in the Aiken county jail and John DuBose, Smiley Randall and Jet Atkinson are held in the Windsor

The injured are Aleck Nun, shot in the arm; George Weatherford, shot in the leg; Sweet Cushman, brother of the dead man, shot through the hand. The fight, which was general, seems to have grown out of an attempt to intimidate the officer, John Cleckley, who was formerly a member of the police force in Aiken, and for the past year, since Windsor was incorporated and a branch dispensary located there, has been town marshal of Windsor. Threats have been made, it is alleged, to drive him away from the town because of his activity in maintaining law and order, and last night the trouble began when, between 8 and 9 o'clock, the officer heard a shot fired

in Jet Atkinson's butcher shop. Going into the shop Cleckley found a crowd gathered and saw something elash as it fell into a tub of water.

Thinking it was a weapon that some one had thrown away, he made a search tor it but without success, then demanded to know who fired the shot. He arrested Atkinson, whose sons were present, and it is said, declared that their father should not be taken into custody without a fight. Outside the door on the street the fight began as Cleckley led Atkinson away toward the town lockup, and no one will ever know how many shots were fired.

There was a fusilade which brought Cleckley's assistant, L. B. Johnson, to the scene to help his chief, and an other fusilade followed, and when the smoke had cleared away Hauford C. Cushman, who is familiarly known as 'Son," lay dead and the others who were shot were nursing their wounds.

The combatants not only used their guns but brought knives into play, Cleckley sustaining several severe cuts in the arm and face and head. He and his assistant, however, made wholesale arrests, locking John Dubose, Smiley Randall and Jet Atkinson in the Windsor jail before coming to Aiken, where they are being held pending an investigation.
