Addresses were made by S. F. Hunniont, editor of The Southern Cultivator, Charles S. Barrett president of the national union, John L. McLauren, former United States senator from this state, T. W. Carter president of the Mississippi Farmers Union, and W. B. Pace, president of the United States Trust and warehouse Company. The addresses dealt mainly with methods of marketing crops, the speakers dwelling on the necessity for business-like procedure.  
President Dabbs and Mr. McLaurin were appointed a committee to frame a cotton warehouse bill that will stand the test of the courts.
