DR. HALLMAN PAYS TRIBUTE TO JONES.

Former Lexingtonian Interviewed and Talks Interestingly of His Associations and Knowledge of Former Chief Justice.

Several days ago Rev. S. T. Hallman, D. D., of Spartanburg, formerly of Lexington county, and one of the best known and most highly honored Lutheran ministers in the South, paid a high tribute to Judge Ira B. Jones. The tribute to the former chief justice was contained in conversation with a well known educator of Spartanburg.

"Yes," said the doctor, "I have known Judge Jones now over 40 years; we were in college together, and he was always a manly boy-bright, straight, clean, a fine student, 'thoroughly honorable, a warm, sympathetic friend, and a man of dignity and of undoubted reliability.

"In the years of our college association at Newberry before the college, temporarily, was moved to Walhalla. I do not recall a single complaint ever being made against him by professors or students. He was always in his place, and his bearing in the class room and on the campus was of so excellent character that, in all the years since, I have carried with me the image of a fine, manly young man, deserving my highest esteem and worthy of the honors which have been so properly bestowed upon him."

Rev. S. T. Hallman, D. D., has been for over 44 years one of the most highly honored and successful ministers in the Southern Lutheran church. He has occupied preminent pulpits in his denomination; has built and successfully financed the affairs of a number of important missions; was the publisher, by official request, of the Ladies' Missionary Journal of the United Synod in the South, and was more than 10 years the editor of the Lutheran Visitor, the leading paper of his denomination in the South. He has been a member of the board of trustees of Newberry college some 30 years, was its secretary 10 years, and has been the secretary of the United Lutheran Synod in the South now 10 years, which synod embraces eight States in its organization.

Dr. Hallman was born and reared in the Black Oreek section of Lexington county, where many of his relatives now reside.




