Solicitor Timmerman has caused warrante to be issued for the arrest of several witnesses in cases which were to have been heard at the recent criminal court, and when called, failed to appear. These witnesses were under bond to appear and their failure to appear not only make the boudmen liaible for the amount of the bond but places the witnesses in contempt of court. The law requiring all liquors, wires and beer seized by the sheriff or State constabulary from illicit dealers to be destroyed is, to say the least, a silly one. The State of South Carolina is in the liquor business whether its sale is placed in the hands of the county having a dispensary or in the hands of the Devil, matters not, the fact remains that the State is in the business and through its agents it buys and sells intoxicating liquors, hence, is it not a more business-like proposition, instead of wasting the whiskey seized by the officers of the law as is now done under the provision of the Cothran-Cary Act to place all alcoholic liquors them in the nearest dispensary or rum shop and sold and the proceeds be placed to the credit of the expense account necessary for the enforcement of the law?

#### Presentment of Grand Jury.

On Monday, January, 13th, 1912, upon the convening of the January Term of Court of General Sessions for Lexington County, State of South Carolina, the Grand Jury was duly organized by the appointment of R. L. Lybrand as foreman and the administering of the proper oath and the charging of all the members of this body with the responsibilities and duties pertaining to the office of a Grand Juror.

After the completion of the organization of this body, the Presiding Judge, the Hon. Frank Gary, delivered our body a brief, clear and impressive charge, as to our powers, responsibilities, duties and obligations as a grand jury-

We have handed us by the court a number of bills of indictment, all of which we have fully investigated and carefully considered, and have returned each and every bill of indictment to the court with our findings endorsed

We have inspected the county jail and find that the same is well kept and in good conditon.

We have appointed a committee of three, consisting of Isaac Edwards, E. W. Shull and W. L. Shull to inspect and report on the condition of the County Poor House and Farm. This committee has visited the County Poor House within th past few days and report that the inmates are well cared for and that they are satisfied with the treasment and attention given them by the officers in charge. We find that this institution needs a good milch cow, as the cow now on the county farm is in bad condition and unfit for milk, and recommend that the proper officers secure a good cow as soon as practicable.

We do not know whether or not the buildings at the County Poor houses are insured, and if they are not insured, we recommend that the County Supervisor have all of said buildings insured as from reports made to us it seems that they are in great danger of being burned. We also recommend that the pasture be enlarged and that the farm be furnished with more bogs as there is only one hog on the farm at present.

We recommond that the roads and bridges of the County be looked after at once, as it is reported to us that some roads and bridges within our County are in a dangerous condition some cannot be traveled by the public at all. Immediate attention should be given to such roads and bridges as are unfit to traveling over.

Numerous reports have reached us that several so called Social Clubs are being operated at different points in our County, and that none of them are being run according to law. We therefore recommend that all such clubs or places of resort where alcoholic I quors are sold be closed and that the party or parties operating same be prosecuted.

Because of the lack of time at this term of Court we will not be able to inspect the offices of the County officers, but all such offices will be duly and properly examined and our report made at a later term of the Court of General Sessions

We wish to express our appreciations for the favors and courtesies shown us, by the Presiding Judge and other court officials at this term of court. Respectfully submitted,
