Congressional Legislation.

In a former number we expressed the fear that Congress would take such action upon the reconstruction measures as would narrow the basis of our rights still further. That fear has been realized. An Act explanatory of the Act of March 1867, passed both Houses on the 12th instant. This Act not only declares that the military commanders possessed the powers which they claimed to the fullest extent, but goes further.

1st. It declares the governments then existing in the rebel States as illegal and if continued subject in all respects to the military commanders and to the paramount authority of Congress.

2d. It ignores the President entirely, and subjects the acts of the District Commanders to the approval or disapproval of the General of the Army (now General Grant.) 3d. The power of the District commanders to remove State officers at will and ap-

point others is clearly affirmed. 4th. The power is also given to the General of the army of the United States to suspend, remove and appoint, State officers.

5th. The Acts of the District Commanders in removing persons from office and appointing others in their stead, are confirmed; and it is declared that it shall be the duty of such commanders to remove from office as aforesaid all persons who are disloyal to the Government of the United States, or who use their influence in any manner to hinder, delay, prevent, or obstruct, the due and proper administration of this Act, and the acts to which it is supplementary."

6. The Boards of Registration are vested with full powers to judge of the qualifications of persons proposing to register their names as voters, and not to allow the registration of any person they may decide not to be " qualified to vote; their action however to be subject to the approval of the District commanders; and no person is to be disqualified as a member of any board of registration by reason of race or color.

7. The true intent and meaning of the oath prescribed in the Supplementary Act of March, 1867, is declared among other things to be as follows; to wit: that no person who has been a member of the Legislature of any State, or who has held any executive or judicial office in any State, whether he has taken an oath to support the Constitution of the United States or not, and whether he held such office at the commencement of the rebellion, or had held it before, and who was afterwards engaged in insurrection or rebellion against the United States, or giving aid and comfort to the enemies thereof, is entitled to be registered or to vote, and the words "executive or judicial office in any State," in said oath mentioned, shall be construed to include all civil offices created by law for the administration of any general with freckles. 10. Members of boards of registration and crease of divorces in that State.

State officers appointed by the District Commanders are required to take the oath of office, known as the "iron clad."

11. The District commanders, members of boards of registration, and persons acting under them, shall not be bound in their action by any opinion of any civil officer of the United States. Such are the main provisions of this Act. The reader will readily perceive that most of the points of construction which it makes are in direct conflict with the opinion of Attorney General Stanberry. The Ac. was intended to destroy the force and effect of that opinion, and at the same time to remove the hand of the President from any and all participation in the work of reconstruction.

Henceforth our people should distinctly anderstand, that the government they are living under is purely military, and that those who hold offices, known to our laws as "civil offices." hold them at the will of the District commanders, and are merely his subordinate agents in carrying on the goverument and administering the laws.

The effect of this legislation is also to oust the President of the United States from all authority or jurisdiction in these States, except in the appointment of federal CIVIL officers. General Grant is now the President of these States. He is our ruler except when Congress intervenes. What an anamolous where is the ship of State drifting? > Letter from Gen. Sickles. Gen. Sickles has addressed the following letter to the Hon. Lyman Trumbull, Chairman Judiciary Committee, United States

> CHARLESTON, S. C., July 5, 1867. MY DEAR SIR: I have decided not to begin registration in this district until Congress determines who shall be registered. I of Congress to extend the time for the completion of my registration, until-say, October or November. If I proceed now, and disregard the wishes of the President, my action would be regarded as insubordination; if I follow his intimations, many would probably be registered not eligible according to the true interpretation of the Acts of Congress.

> If it is meant that all who have held any office-Federal, State or municipal-having taken an oath of office to support the Constitution of the United States, and afterwards engaged in rebellion, or given aid, comfort, etc., are disfranchised, this should be expressly declared; otherwise, if left to construction, it may be held that no other of ficers are included than those classes enumerated in Article VI of the Constitution, and that even as to these a full pardon removes the disqualification.

> If it is meant to exclude lawyers, they should be expressly mentioned, or else described by some classification; ample, after the word "office," add "any icensed calling or employment or profession." Otherwise, if the eligibility of lawyers be feft to construction, it may be held that a lawyer is not a public officer, although a functionary of a court or other judicial The truth is, we have now in operation

two distinct systems of reconstruction, originated by Congress, and engrafted upon the President's plan of reconstruction. The first Congressional plan is expressed in the particulars, terms, &c., see card else-Howard constitutional amendment, leaving inffrage to be regulated by the several States, and imposing upon certain classes of persons disqualification for office, as a punshment for rebellion and as a safe-guard for the future. That plan having been refused by the rebel States, Congress passed the reconstruction Acts, which form a second scheme of reconstruction, entirely dis tinct in principle and plan from the former. In the second plan, Congress assumes control of the question of suffrage, which is extended to all who can take a prescribed oath, and also enforces the disqualification for office, which would have been the penal and conservative feature of the first plan. Now, it seems to me that the true conservative guarantee against reaction is in the addition made to the loyal vote by the enfranchisement of the colored people. That being done, the occasion for the disqualification clause ceases. Hence the true solusuffrage, a general amnesty-naming the exceptions. A more liberal amnesty is, in my judgment, essential to the success of the Congressional plan of reconstruction. It will enlarge the range of popular choice for the important judicial, executive and legislative departments of the State Governments, otherwise inconveniently confined to classes very few of whom are fit to hold

> The people can surely be entrusted to udge and select from those who took part in the rebellion, the men at once qualified and sincere in their adhesion to the new order of things. Such men, being eligible to office, will have motives to identify themselves with reconstruction, and to support the views of the majority. Now, more than ever, men of ability and experience in public business are needed for the State covernments in the South : and it is truly unfortunate that at such a moment nearly all who know anything of public affairs, and especially those who could fill judicial stations, are disfranchised. This exposes the experiment of general suffrage to needless hazards. If the experiment fail, it is most likely to fail from the inability of the people to put in office those who could and would assure success. It would have been advantageous, perhaps, to have removed many disaffected persons, especially judges, sheriffs and magistrates, in the execution of the sixth section of the Act of 2d March, if competent successors could have been found

among those who are eligible to office. And I would regard the possession now of a wider field of choice for civil officers, as one of the most effective instrumentalities in the execution of the military authority conferred upon District Commanders. As it is, I find myself prevented, as will the people by and by, from securing for the public s rvice men of aptitude and character, whose repentance is as certain as the devotion of the most consistant lovalist. In truth, the zeal of some of the converts out-runs the discretion of many of the faithful. With reference to other practical suggestions, it might be useful if Congress, by one of its committees, interrogated the commanding officers of the several Districts upon the operation of the reconstruction
