Brown & Moseley, and \$748.55 to the National Bank of Newberry. There are other small liabilities, which can probably be covered by funds on hand. The resources, or assets, consist of the Fair Grounds, (8 3-4 acres) and the im-

He charged the demout against a tree in front of the Webb ocratic party with fraud in elections, extravagance, failure to keep the promises made in 1876, and abused the new Registration law.

Mr. George Johnstone, of Newberry who happened to be present, was invited to make a speech, and he followed Mr. Russell. He began by saying that when a person advises another to change his business or his place of residence the burden of proof is on the party giving the advice to show (1) the necessity for a change, and (2) the probability that the change advised will be a beneficial one. The Greenbackers have failed to show any advantage to be gained by a change, or that a change is needed. He then proceeded to answer the charges against the democratic party, and did so to the apparent satisfaction of the audience. As to the Registration law, he said the Constitution made it incumbent on the Legislature to pass such a law; that the republicans having failed to pass the law, the democrats did so for the purpose of preventing frauds at the ballot-box.

SECTION 2. That a tax of one dollar upon each dog within the limits of the Town of

Newberry shall be levied and paid into the reasury of the Town of Newberry. SECTION 3. That a tax of four dollars shall be levied and paid into the treasury of the Town of Newberry upon every wagon or dray drawn by two horses that shall be used for hire or public employment within the limits of the Town of Newberry. SECTION 4. That a tax of two dollars shall be levied and paid into the treasury of the or dray drawn by one borse, upon every omnibus, carriage, buggy or barouche used for hire or public employment within the

limits of the Town of Newberry. SECTION 5. That each auctioneer within he limits of the Town of Newberry, shall be required to take out a license before exercising his business as auctioneer, and hall pay into the Treasury of the Town of Newberry for said license the sum of twen-

ty-five dollars.
SECTION 6. That the proprietor or prietors of each billiard or pool table within the Town of Newberry, shall be required to pay into the treasury of the said Town of Newberry the sum of fifty dollars as a license therefor, and that the proprietor or proprietors of each billiard or pool table within the Town of Newberry in cess of one such billiard or pool table shall be required to pay into the treasury of the Town of Newberry the sum of twenty-five dollars for each of such billiard or pool ta-

bles in excess of one.
