The Message of Gov. Hagood.

The last Appual Message of Gov. Hagood to the Legislature is an able document, and sets forth the condition of public affairs plainly and minutely. attempt to give the substance of it. colored children. An appropriation

is \$6,571,825, bearing interest at 6 per cent. The debt was decreased the past year \$70,496. The State securities sell upon the market above par. The current expenses of the State are met by current funds : and there is a balance of \$98,017 in the Treasury, awaiting Legislative disposition.

THE REVENUES OF THE STATE for current expenses are derived from the net earnings of the penitentiary, the phosphate royalty and taxation. The penitentiary paid into the Treasury the past year \$40,000; the phos phate royalty \$138.254; the State Tax was 44 mills. The ordinary expenses of the State government for the next year can be met by a levy of 1 a mill: the public debt will require of the militia better than in 1881; 3 1-10 mills more, making 3 6-10 and he wants an appropriation of mills. But \$100,000 will have to be \$22,700. parrowed to pay interest on the public lebt in anticipation of the collection of taxes; and to do this will require 8 10 of a mill more, making the total tax levy 4 4.10 mills. The Message recommends that the first annual payment of taxes, in the spring, be made compulsory, so that there will be money in the Treasury to pay the interest on the public debt as it fulls due without having to borrow from the banks.

THE STATE PENITENTIARY. The 1st of November there were 824 convicts in this institution, against 690 at a corresponding period in 1881; 778 are colored, 46 white. Of the 324 convicts, 224 were leased upon phosphate work; 121 were leased upon ailroads; 25 upon the Seegers farm. and 454 within the walls of the prison. Of those within the prison 97 were at work with a contractor in making shoes, 120 at work on the Columbia canal, and the remainder in various employments. A large amount of work has been done upon the penitentiary itself, and also upon the Columbia canal. The Superintendent's Report exhibits the following transactions: A balance in hand at the beginning of the fiscal year of \$21,199: earnings for the year, \$94,236; expenses proper of the penitentiary, \$50,989; per diem and mileage of Board of Directors, \$1,267; paid on canal, \$8,096; paid into State Treasury \$40,000; and remaining in hands of Superintendent, \$14,901. This last amount is in cash and bankable

notes given for convict labor. This exhibit contrasts favorably with the management of the penitentiary in the period from 1868 to 1876. Then, beside the earnings of the convicts, it required an annual average appropriation of \$62,800 from the State Treasury to support the institution. In the health, general appearance and judicious discipline of the convicts, a like improvement appears.

The attendance upon the public schools the past year was 145,974; whites 65.399, colored 80,575; number of teachers 3,413; white 2,126, colored 1,287: number of schools 3,183; average length of session four months; school fund \$452,965.44. The Military Academy at Charleston opened last October with 177 students, 68, or two from each County, being benefind ries whose tuition, board and clothing are paid for by the State. The students are provided with rooms, the only charge being \$10 a year for repairs, and tuition is free to all whose parents reside in this State; they pay their own board. 
