# LANDS ON "NUBBIN RIDGE"

# Now Worth \$50 per Acre-Tract Given "To Boot" in Horse Trade Worth \$54 per Acre.

# [Columbia State.]

Walhalls, April 18 .- Perhaps in no other county in South Carolina has there been a larger increase in value of real estate of all kinds than there has been in Oconee during the last five years. While the value of real estate has been increasing for several years it has been only within the last two or three years that property has been bought and sold for prices that only a few years back would have been considered marvelous. In all the towns of the county the prices of houses and lots have been spoken of as almost prohibitory, but in all these instances the purchaser has been able at all times to sell at an advance if he so desired.

What is true of town property is equally true of farms and forests throughout the entire county. The high price of cotton, better farming methods and general prosperity of the people have made the farms more desirable. Another thing that has caused farm lands in many sections to advance is the coming of farmers from Anderson, Abbeville and other counties. They sold their farms for good prices and came up here, bought just as good farming lands for about one-third as much as they sold theirs there for and now have just as good lands, crops and homes as they had formerly. They brought improved farming methods and when they began to use them their neighbors have not Alfred Perritt, farming methods and when they began been slow to join the prosperous procession.

The general scarcity of and great demand for timber has caused the lands in all our mountainous sections to become more valuable. Many men are to day selling their timber off of their land for a sum per acre that would have been considered, five years ago, many times the value of the land. This applies to good strong farming lands and not to bare mountain peaks.

In the lower sections of Oconee-Fair Play, South Union, Oakway, Tokeena and other sections-land is considered very cheap at \$20 per acre. And much of this section, which was formerly called "Nubbin Ridge," is now worth \$50 per acre. Recently one man sold his farm near Tokeena for \$54 per acre. This is a part of a very large tract that was given, just before the war, "to boot" in a horse swap.

In the South Union section, where the price is from \$20 to \$50 per acre to-day, 1,000 acres were once given in exchange for one dozen gun locks, valued at \$5 each. Recently a valuable farm in the Richland community was sold for 200 per cent more than the purchase price five years ago.

Ten miles north of here, near Salem, is a farm that has been sold several times within the past five years. The latest purchaser gave more than twice as much for it as the original purchaser, who gave what was then considered a good price.

In short, from all sections are examples to show the true rise in the value of lands. What is true at Oakway and Salem applies equally as well to Double Springs and Long Creek. There are numerous instances in Walhalla where property has advanced from 50 to 200 per cent within the last five years.

For years there was but little growth here, but for some years the growth has been regular and rapid and no man owns land here now that he cannot dispose of for a good price. It is also true, along with increased value of real estate and general prosperity, that the county has grown in morality and sobriety. The water is good, the climate unsurpassed

# Many Earthquakes in Last Two Centuries.

Among memorable earthquakes of ecent times may be noted that of Lisbon, November 1, 1755, which left the city a heap of ruins, destroyed 60,000 lives and was felt from the Madeiras to Great Britain; that in Calabria in 1783; that which destroyed Caracas in 1812; that which destroyed Aleppo in 1822; that at Mount Ararat in 1840; those at Brusa, Asia Minor, in 1855; Naples, 1857; Quito, 1859; Mendoza, Argentina, South America, 1860; Manila, 1863; in Peru, 1868; Manila, 1880; Valparaiso, 1880; Ischia, 1883; the earthquake phenomena accompanying the volcanic eruption of Krakatoa, 1883; Colchester, in the eastern counties of England, 1884; Malaga and Granada, 1884 and 1885; Charleston, 1886; Japan, 1891; Chilpaneingo, Mexico, 1892; Guatemala, 1892.

In the Charleston earthquake 27 persons were killed outright, and it is estimated that probably 75 died from injuries received. The property loss was officially estimated at \$5,000,000.
