#### SENECA NEGRO GOLLEGE DYNAMITED CITIZENS IN MASS MEETING CONDEMN

LAWLESS SPIRIT.

Senson, Oct. 16.—Sensera white citizens are deploring the attempt to dynamite the building which is being built for a colored college, which occurred last Fri-day night, and about which the daily papers have contained full accounts. There seems to be no clue whatever to the causes or perpetrators of the deed. It is reported that Williams, the colored preacher, who has the building of the college in charge, has been offensive to-ward the other colored college here, and that feeling between the two factions has been aroused. It is also reported that Williams has courted the ill will of the whites here on account of alleged state-ments that Williams has made from time to time, bearing upon the attitude of the blacks toward the whites. Williams de-nies both charges stoutly. Whatever the facts in the case may be, it is an ugly affair, and is receiving the thoughtful attention of the citizens here. At a mass meeting of the citizens last night, called for the purpose of concider-ing the matter, strong resolutions were

night, called for the purpose of consider-ing the matter, strong resolutions were passed condemning the act, and the Town passed condemning the act, and the Town Council was requested to offer a suitable reward for the arrest and conviction of the guilty party. Notice of Election.

County of Oconee. { Notice is hereby given that the General Election for Representative in Congress will be held at the voting precincts fixed by law in the County of Oconee, on TUESDAY, NOVEMBER 6th, 1906, said day being Tuesday following the first Monday, as presoribed by law. The qualifications for suffrages are as follows:

The qualifications for suffrages are as follows: Residence in State for two years, in the County one year, in the polling precinct in which the elector offers to vote, four months, and the payment six months be-fore any election of any poll tax then due and payable. Provided, That ministers in charge of an organized church and teachers of public schools shall be enti-tled to vote after six months' residence in the State, otherwise qualified. Registration.—Payment of all taxes, including poll tax, assessed and collecta-ble during the previous year. The pro-duction of a certificate or the receipt of the officer authorized to collect such taxes shall be conclusive proof of the payment thereof. Before the hour fixed for opening the polls Mausgers and Clerks must take and

polls Managers and Clerks must take and subscribe to the Constitutional oath. The Chairman of the Board of Managers

The Chairman of the Board of Managers can administer the oath to the other Managers and to the Clerk; a Notary Public must administer the oath to Chair-man and Clerk. Polls at each voting place must be opened at 7 o'clock a. m., and closed at 4 o'clock p. m., except in the City of Char-leston, where they shall be opened at 7 a. m. and closed at 6 p. m. The Managers have the power to fill a vacancy; and if none of the Managers, who, after being sworn, can conduct the elec-tion.

tion At the close of the election, the Managers and Clerk must proceed publicly to open the ballot boxes and count the bal-lots therein, and continue without ad-

lots therein, and continue without ad-journment until the same is completed, and make a statement of the result for each office and sign the name. Within three days thereafter, the Chairman of the Board, or some one designated by the Board, must deliver to the Commissioners of Election the poll list, the boxes con-taining the ballots and written statements of the result of the election.




