#### LIEN LAW ABOLISHED.

Twenty-Four Senators Vote to Repeal Law and 12 Oppose It.

Columbia, Feb. 17.-The Senate to-night by a vote of 24 to 12 passed the lien law repeal bill, which has past two days. Nearly every Senator has had a say on this measure. It was thought t. at a vote would be reached immediately on this bill on which all Senator; naturally had their minds made up. Senator Kelley was willing for vote to be taken at once, but discussion arose and continued for the past two days and nights. The House passed the bill by a vote of 85 to 35.

The vote in the Senate stood as follows upon Senator Kelley's motion to table Senator Montgomery's motion to strike out the enacting words of the bill:

Senator Weston, speaking on the bill, pointed out the fact that the South furnishes three-fourths of the cotton of the world. "In spite of the world to-day." he said. "The poor man has the sympathy of all, and legislation should be directed to help him out as far as possible." He referred to the work done by the Southern Cotton Association and the Farmers' Union. He praised these organizations, which have done so much for the farmers. He called attention to the methods by which those who wished to control the cotton market obtain knowledge of the time liens were due, and the cotton had then to be put on the market.

"We have become a one crop people," said Mr. Weston, "and because of the impetus given by the lien merchants. If you repeal this lien law, it will go a long way toward making our people independent of the corn and meat now received from the West. There may be hardships at first, but in the end it will bring happiness and prosperity."

He argued that lien givers are rarely ever able to pay out entirely. The man who gives a lien is in bondage for a while, and then he has to give up his business entirely. The organizations mentioned have both declared themselves to be in favor of abolishing the lien law. 'Why should we say we know more about this business than the farmers themselves?" he asked.


