The present agitation of the question of completing the old Blue Ridge Railway through to Knoxville and the West has revived an interest locally that we had not even dared to hope for in its proportions of enthusiasm and spirit of hopefulness and helpfulness.

Locally it is a topic that, where two or three are gathered together, soon becomes uppermost, and on every side there is a spirit that tends to show that everybody not only hopes for the completion of the road, but stands ready to do his part toward bringing the present agitation to a successful conclusion.

But the Blue Ridge propostion is by no means a local question. It is one that must affect materially every town and every section between Walhalla and Charleston, and mainly, as we see it, the cities of Anderson and Charleston, with Walhalla as not less than third in interest.

While these places are deeply interested, and will possibly derive the greatest direct benefits from the completion of the road, there is not a town, not a way-station along the route, from the mountains to the sea, that will not receive its full share of benefits that must follow the opening of such a great trunk line of railway as this proposition affords. It will not only prove the consummation of what years ago was recogmized by our great leaders in commercial affairs as the great need of a great section, but it is bound to prove the greatest builder of a great section of country that to-day stands with beekoning hands calling for the help of just such a great commercial highway, that the known wealth of the grain fields of the West and the coal fields nearer home may be tapped with the same stroke that is

Judge Outraged at Verdict.

Wilmington, N. C., April 9 .- Outraged at the verdict of not guilty by the jury in the case of Joseph Ste-phens, acquited of murder after having previously been convicted and sentenced to electrocution, but granted a new trial by the Supreme Court. Andge Robert B. Peebles, of the State Superior Court, has issued a bench warrant for the defendant in the for-mer case and he was arrested and held until the next term of court on a charge of carrying concealed weapons, the judge certifying in the warrant that under his own admission at the former trial he is at least gailty of the latter charge preferred against him.

Judge Peebles severely criticised the jury which returned the verdict. ordering members from the court house, and to-day an affidavit of the State Solicitor removed three other capital cases to an adjoining county for trial.

THE HETRICK HOSIERY MILLS.

Chamber of Commerce Puts Proposition Before Spartanburg Citizens.

(Spartanburg Journal, 7th.) The Chamber of Commerce will tomorrow go before the people of Spartanburg with a definite proposition regarding the establishment here of Mills, of Walhalla.

The proposition made to the city of Spartanburg by Col. Jaynes, the head of the company at Walhalla, is thought by the Chamber of Commerce committee to be as liberal as could be desired, and the committee is recommending it most earnestly to the consideration of the citizens of

Couldn't Get Labor. Because of their inability to secure the Walhalla plant have been forced o seek elsewhere for a location for the installation of that part of their machinery which has been lying idle at Spartanburg only a small plant where they could get labor for knitting, the idea being to do the finishing and dyeing at Walhalla. They have been so much pleased with the outlook at Spartanburg, however that they now propose to buy new machinery in addition to what they have, put in a modern dyeing plant and equip a complete knitting mill in Spartanburg.

Asked to Buy Stock.

The capital stock of the present organization is \$33,000. It is proposed to increase the capital stock to not less than \$60,000, of which \$40,000 will be of 7 per cent preferred stock and \$20,000 common stock. tanburg is asked only to subscribe for \$5,000 of the preferred stock. The proposition made to the gentlemen from Walhalla was to the effect that Spartanburg would endeavor to make this subscription and also to give the new organization the use of the Russell Machine Works' plant at a rental basis of 6 per cent upon an option price of \$15,000, the Hetrick Company to pay the taxes, repairs An option upon the Russell property for a period of ten years for the sum of \$15,000 is to be given.

It will be remembered that this propercy was recently bought by H. B. Carlisle, who has agreed to turn it over for this purpose at the above

The plan of the Chamber of Commerce committee is that a holding company be organized for the purpurchasing the Russell property and leasing it to the Hetrick Mill Company on the above basis. Subscriptions to this holding company and to the preferred stock of the mill company in the amount of \$5,000 will be asked of the Spartan-burg people at once. It is emphathat of the \$40,000 preferred stock Spartanburg is only asked to subscribe this small proportion. All the money received from the sale of stock will be put into the plant. The preferred stock will thus have beaind it assets to the amount of at

Committee Enthusiastic.

The committee which met with Col. Jaynes and the Messrs. Hetrick yesterday is composed of J. W. Alexander, John B. Cleveland, H. B. Carlisle, W E. Burnett and H. E. Ravenel. These gentlemen are enthusi-astic over the proposition and will position that can be brought forward do all in their power to secure the enterprise for Spartanburg. Jaynes outlined a proposition to-day received from another city, which was even more favorable than the one received from Spartanburg, but for various reasons he preferred to come here if the necessary arrangements could be made. The mill will have a capacity of from 400 to 600 dozens of the very highest grade hosiery, for which a market has been assured at stable prices. It will employ from 150 to 200 people at wages from \$6 to \$12 per week. The committee in charge of the proposi-

The Reason for Branch Plant.

For quite a while it has been the effort of the hosiery mill people of Walhalla to secure sufficient operatives to run the plant in Walhalla full capacity and full time, but they have found it absolutely impossible to secure more than about one-tihrd the number of operatives to carry out this plan, and as a consequence much of their machinery has been idle practically all the time. Only recently the plan of carrying the idle machinery to some point where help could be secured was hit upon as the best solution of the problem of operating the plant at full capacity.

The original plan, as stated by the Spartanburg Journal, was to divide the plant in such manner as to do the knitting and first work at Spartanburg or some other point, com-pleting the product at the dyeing and finishing plant at Walhalla. With true Spartanburg spirit, however, the Spartanburg people preferred a larer plant and made efforts to that end, with the result that if the branch is established in that city (and it is thought to be practically an assured fact), the two plants, while under one head, with headquarters at Walhalla, will be each complete in itself. Some of the macomplete in itself. Some of the ma-chinery of the Walhalla plant will be shipped to the branch plant and other new machinery purchased to

make two fully equipped plants.
It is matter of serious regret that condition have never been such as to make the operation of the plant here at full capacity, or anything like full capacity, a possibility. Conditions at Spartanburg are widely different, however, and the prospects are for an ample supply of first class hosiery mill operatives within mill operatives within a very short

The change will in no way curtail the number of operatives at the Walhalla plant, but, on the contrary, the mill owners will maintain their policy of giving employment to all available young women who desire to se-cure an unusually nice and clean means of livelihood. The hosiery mill work is run on the piece-work system, the operative making more as they become familiar with the de-tails of their employment. There

are a number of the present operaives here whose daily wage average is from \$1.25 to \$1.75. These operatives were all total strangers to the hosiery business at the start of the plant here.


