#### FLOOD MOVES DOWN THE RIVER

Crisis Not Over, However-Levees Subjected to Terrific Strain.

Vicksburg, Miss, April 11 .--- Dykes at most of the menaced points in the Mississippi flood zone are holding strong against the rapidly descending tide. The water here is 51.1 feet this morning, a rise of six inches during the past 24 hours. The rise at Natchez is slightly more.

The Mississipi river's angry torrent has temporarily halted its work of devastation. Aside from a continuance of the break in a cut-off embankment above Natchez, Miss., no further crevasses were reported last night along the threatened stretches of dikes.

Despite this temporary abatement of the damage caused by the torrents which sweep down the valley, the crisis is not past. As the tide continues southward, many points between Baton Rouge, La., and Helena, Ark., must stand a terrific test. If they fail then hundreds of square miles in some of the world's richest agricultural territory may be flooded, many bustling cities inundated and life threatened.

As the rise of the flood continues from Arkansas City downward, the stress of the threatened embankments has increased and anxiety grows among the myriad workers toiling to reinforce the dikes, Army engineers declare they have the situation under control at Miller's Bend. the levee guarding Greenville and the Southern Delta's fertile acres. This point was regarded yesterday as one of the most menaced in the danger zone. The crest will not reach Greenville

for three days or more. If the rise continues gradual, it is believed the dikes can be sufficiently strengthened to contain the flood.

#### Work of Rescue.

Memphis, April 11.-Although wires are down to a large part of the territory in northwestern Arkansas, inundated yesterday, accounts re ceived by boat are reassuring.

A tug went to the aid of R. H. Campbell and his launch "Good News," taking a supply of gasolene, food and bedding. Other boats followed to render further assistance to refugees at Edmondson and Kate, Ark., and other small towns nearby. Work of rescuing about 200 men who were left on knolls, house tops and in trees when their womenfolk were taken to safety in Campbell's the crowds in the street below. launch, is being continued, and it is now believed all will be brought safely out of the flooded district, Advices from the Reel Foot Lake district continued to be reassuring. Work of relief has been thoroughly systematized and few persons are believed to remain in danger or in want. Boats patrolling the section near Wyanoke, Ark., to-day returned with the news that no more refugees were to be found. Those brought to Memphis are being cared for.

HAS ANOTHER DARING ESCAPE.

Daring Jumper's Parachute Opened Just Before He Hit Flag Pole.

New York, April 11 .--- Wall street was startled yesterday by the thrilling leap of Frank Law, a parachute jumper, who descended in his parachute from the Banker's Trust building to the roof of the sub-treasury, a distance of 500 feet, landing practically unhurt.

This latest exploit of Law, who has been jumping from all the tall buildings he can find, narrowly missed ending in a tragedy. His parachute was slow in opening, and he was almost impaled on the flagstaff of the sub-treasury building. Only a quick kick, changing the course of the huge umbrella, saved him. As It was his parachute hit the flag pole a glancing blow. This caused the parachute to tilt slightly, and it was barely righted when the jumper landed on the roof of the building. Law was momentarily stunned, but jumped to his feet and waved to Law recently jumped from the torch of the statue of liberty with a a nute. Endeavoring to win a \$1,000 bet that he would clinib up the side to the top of a 26-story building in New York and then jump from the top in a parachute, he got as far as the fourth story when he was espied by a vigilant New York policeman, who rushed up the stairs to a window on the fifth floor and compelled the nervy climber to come inside. Law declares that he will yet accomplish the feat, and because of

#### WOMAN SENTENCED TO DEATH.

#### Convicted of First Dogree Murder, Alleged Crime Described.

Newport News, Va., April 10.-Virginia Christian, a young colored woman, who has been on trial in the Hampton Circuit Court for the past two days on a charge of murdering Mrs. Ida Virginia Belote, was yesterday, afternoon found guilty of murder in the first degree, and her punishment was fixed at death in the electric chair.


Mrs. Belote, a widow, with eight children, was found murdered at her home in Hampton on March 18. She had been beaten over the head with a heavy earthen cuspidor until unconscious, after which she was choked and a towel crammed down her throat. A broom handle, was used to force the towel into the woman's mouth. Robbery and revenge were ascribed as the motive for the crime. The dead woman's pocketbook, together with several bloody garments, were found at the Christian girl's home, and the evidence against her was conclusive.

If the sentence of the jury is carried out it will be the first execution of a woman in this State since the inauguration of the electric chair as a mode of inflicting purishment.

The flames shot very high and the smoke and ashes were blown far out to sea. The property loss is reported to be heavy.

Capt. Olsvik, of the Fort Morgan, in describing the scene, says that it was the most terrifying imaginable. The sea was torn up and islanders were up to their necks in water.

It is reported that the shock of eruption is being felt at Culebra Cut. Panama Canal, and men on the Fort Morgan say that the water in the cut, according to reports reaching Bocas, has risen two feet within the past few days. This is attributed, they say, to the volcanic action.

With regard to the eruption of Chiriqui Peak, Capt. Olsvik said:

"The Fort Morgan was berthed at the Almirante wharf, about 14 miles from Bocas Del Toro, on the morning of April 5th, loading bananas, when about 4 o'clock the eastern sky blazed forth and a great rumbling was heard. Looking in that direction, I saw great volumes of fire shooting high.

"The natives who had been loading the ship all night, were terrorstricken; some of the men fell on their knees and prayed. All work was suspended for several hours as the people watched the volcano.

"I learned before leaving that the third of a row of mountain peaks, situated about a mile from us, had burst into flame, or had turned into a volcano. The peaks were southeast of the Fort Morgan and are called the Chiriqui. The peak that became active was the highest of the number, its height being estimated at 2,340 feet above sea level.

CLARA BARTON DEAD AT 91.

ounder American Red Cross Society. Death Caused by Pneumonia.

Washington, April 12-Miss Clara Barton, founder of the American Red Cross Society, died at her home at Glen Echo, Md., this morning. Her death was due to pneumonia, with which she was stricken a year ago. She was 91 years old.

Miss Barton was called "Florence Nightingale of America," such were her many acts to relieve suffering in war, pestilence and disaster. She was active not only in her own land, but in other parts. She distributed relief after the Johnstown flood; to survivors, after tidal wave which struck South Carolina and Florida; went to Russia in 1892 to carry food to the famine stricken; in 1896 aiding Armenian families after Turkish

massacres. When yellow fever appeared among the American troops in Cuba, it was Clara Barton who, at the request of President McKinley, organized field hospitals and personally visited the battlefleids. Her last work of national import-

ince was in connection with the Galveston storm in 1900.

She was recognized both at home and abroad with decorations for her work for humanity.

Mountain Rest, April 8 .- Specjal: The farmers around here are getting ready to plant corn, but there is so much rain that the progress made is slow


