Clemson College, Sept. 19 .--- The through the mass of letters, catalogs and quotations that have come into "horticultural extension office the within the last month from nurseries all , over the country, foretells a shortage in nursery stock for planting this fall and winter. With the shortage also comes an increase in price. Pecan stock alone seems fairly plentiful, and has not increased in price to such a great extent as other nursery trees. The shortage leaves a tremendous opening for the unreliable and crooked agent to do a big business.

At present there is no law in this State requiring the fruit tree agent to put up a bond before doing business within its boundaries. The field is open to reliable and unreliable alike: and it is almost impossible to know the reputation of the stranger who comes to your door with highly colored pictures and specimens of fruits and nuts, and with unusual politeness and remarkable fluency of speech secures an order. It is unfortunate for these strangers to have to be looked upon by the intelligent with suspicion, and it is most unfortunate for the few that are reliable to have to suffer for the bad reputation that the majority have established. However, under present laws there is no way to make a discrimination.

The only way to avoid getting "stung" is to order only directly from some reliable nursery and thereby get what you order, and save the middle man's or agent's profit. Those contemplating setting out an orchard, large or small, should make final decision as soon as possible, and place orders for trees before the nurseries are sold out or first grade

Sanders Must Show Cause.

Judge Ernest Moore has issued an order requiring Col. A. K. Sanders, superintendent of the state penitentiary to show cause why county supervisors should not get convicts for county road work from the stath penitentiary. The case is brought in the name of Sumter county by L. D. Jennings county attorney.

The Staff to Attend.

The staff of Governor Cooper will attend the reunion of the Thirtieth division to be held at Greenville, according to an announcement made by the adjutant general.

The staff consists of 40 men from various parts of the state.

Dial Opposes Bill.

Washington (Special) .- During consideration of a bill in the senate to extend the food control law to clothing and food containers and provide a penalty for profiteering, Senator Dial, Democrat, of South Carolina coposed the bill vigorously as an unne cessary extension of war purposes.

Improve Roads Against Winter.

At the meeting of the state highway commission, federal aid requests to the amount of \$83,000 were approved and considerable consideration given to the present condition of the roads in the state.

"Roads in South Carolina are going to be as bad this winter as they were last, unless steps are taken to put them into condition to withstand winter traffic," said a member of the commission in speaking of road problems.

Prices Must Come Down.

That the time has arrived when the retail and wholesale foodstuffs markets should reflect the decline in prices on primary markets, is the opinion expressed by A. D. Oliphant, "fair price" commissioner for South Caro lina.

Engineers to be Employed.

At a meeting of the canal commission it was decided to employ an engineer or engineers to make a complete survey of the canal properties for the state preparatory to pushing the case which the state has in force to recover for the people of the state the canal property from the Columbia Railway, Gas & Electric Company. The survey is being made for the purpose of ascertaining the possibilities of the canal as a navigable body of water and also as a generator of electric power.

University Inventory.

Inventory of the property at the University of South Cerolina, filed with the state budget commission, shows fast-the real estate owned by the state of South Carolina, upon which the university is located, is worth \$645,000; the buildings valued at 437,500; the educational equipment totals \$217,467.67, and that the old library and its valuable collection is worth \$178,110, if it is possible to be a money value on such a treasure. The total property is thus valued at \$1,485,938.71.
