

New York, Sept. 21.—China wants nothing from America in the forthcoming conference on limitation of armament except the right to preserve its national existence and uninterrupted pursuit of happiness in fellowship with the other nations of the world, Dr. Alfred Sze, Chinese minister to the United States, declared at a dinner given in his honor by the China society. ' Declaring that his country had two

"China wants and needs Ameri-ca's help," he said, "but she wants it to be American in fact as well as in name."

Proposed Union of Churches.

Pittsburg, Pa., Sept. 22 .- The proosed union of the pan-Presbyterian Alliance and the Church of England, or the Protestant Episcopal church, was dicsussed here yesterday by the delegates attending the eleventh general council of the Alliance of the Reformed and Presbyterian church throughout the world holding the Presbyterian system.

Discussion of the proposed union, spoken of at Lambeth, Eng., took place, but no agreement was reached. Among other topics spoken of were the re-ordination of the clergy

of the Presbyterian church. This was the outstanding development of the discussion of church unity at the session here.

Held Delightful Joint Session in the Convicted of Rape in April, 1920— Bounty Land Community. Sentenced to Forty Years.

Columbia, Sept. 21.—Kenneth Gossett, young white man of Honea Path, convicted in April, 1920, of rape at Abbeville and sentenced to forty years' imprisonment in the State penitentiary, was released at noon to-day, shortly after Associate Justice T. P. Cothian, of the Supreme Court of South Carolina, after a hearing here this morning, had granted him bail in the sum of \$6,000. His bond was arranged within a short time after the conclusion of the hearing. hearing.

In his decision Justice Cothran deto pass upon the gullt or innocence of Gossett, there were so many contradictory and inexplicable circumstances in the testimony at the trial stances in the testimony at the trial that he could not say that in Gossett's case "the proof is evident or the presumption great," and that, therefore, he was entitled to bail.

Until he is again summoned into court, in the event that he is put on a second trial for his life, Gossett

is at liberty for the first time since he was lodged in the State peniten-tiary nearly a year and a half ago.



Shortage of Ministers Acute.

Pittsburg, Pa., Sept. 22.—The present shortage of ministers is "acute, critical and grave," and the problem must be solved at once if the church is to go forward under the proper guiding hands, according to the report of the committee on home missions of the European section, presented by the Rev. John Hall of Edinbourgh, Scotland, at to-day's session of the General Council of the Alliance of Reformed churches throughout the world holding the Presbyterian system.
A contributory cause to the short-

age was given in the report as "the utter inadequacy of the financial pro-vision made for either minister or missionary."
