SHERIFF RIGGS AND THE HOMESTEAD LAW.—On Monday the 6th inst., Sheriff Riggs was indicted for failure to set off Homestead to L. W. Dash at his request.

The Sheriff appeared with his counsel Col. W. F. Hutson, who contended in an able argument, referring to numerous authorities, that the Prosecuting party was not entitled to have homestead set off in this particular case.

Magistrate Cooke, rendered the following decision.

From the record in this case, the Court issuing the process has certified that the debt, for which the levy was made, was contracted for the purchase of the land levied on and improvements thereon.

Therefore, there has been no violation of the Homestead law, not assuming to decide its constitutionality, which expressly excepts this case.

Sheriff Riggs was then discharged by direction of the Court.

Our latest exchanges announce the death of Gen. John A. Rawlins, Secretary of War.

He was a young man, whose only claim to distinction, previous to the presidential election, was that he was Gen. Grant's Chief of staff during the war.

But having been appointed Secretary of War last spring, he has since that time performed the duties of the office creditably.

He was a man of liberal views, firm in upholding his ideas of the right, and always refusing to make his office subservient to partisan schemes.

By his death Gen. Sherman becomes Secretary of War ad interim.
