Mr. R. S. Hill Interviewed.

The phenomenal industrial development in the city and county of Anderson within the last few years has produced a frame of mind in our people highly appreciative of every effort, founded on solid business principles, made to steadily increase this development; and in no instance has this been so clearly manifested as in the efforts made by our townsman, R. S. Hill, directed to the building of another large cotton mill. Only a few weeks have elapsed since Mr. Hill announced his intention to organize and build a mill, and already there has been subscribed, locally, more than \$200,000. This is considerably more than was ever subscribed, locally, to any enterprise attempted in this County, and demonstrates that our people are fully alive to the fact that natural conditions are rapidly moving the cotton mills from the East to the South, and that no investment promises such rich rewards as cotton mills.

Meeting Mr. Hill yesterday we inquired, "How are you progressing with your mill?" He replid: "Splendidly, and we are thinking seriously of organizing soon. Aside from some right liberal amounts outside, our unconditional subscriptions secured from people in the city and county of Anderson. ple in the city and county of Anderson, now aggregates more than \$200,000."
"Well, Mr. Hill," we continued, "when will you close your subscriptions?"
"We do not wish to close subscriptions and the continued of the continued of

tions earlier than the middle or latter part of January, at which time we hope to be ready for organization. Powto be ready for organization. However, in consequence of higher raw material an advance in mill machinery seems probable, and rather than pay higher prices, we would prefer a smaller mill with as low a cost as is consistent with the best equipment."

Should you decide to organize at so early a date, will you maintain the determination to equip free from indebtedness?"

"Certainly. We propose to adhere strictly to our idea of placing no orders for machinery, and contracting no debt on the plant beyond the amount the bona fide subscriptions to the capital stock, taken in legal shape, as near

as we can approximate, will cover."

"What are your immediate prospects for additional subscriptions?"

"They are very fittering, but our fittends who have signified their intention to take stock with us, or to increase their subscriptions, and are de-laying, considering what amount they will take or increase to, may be disap-pointed in both if they defer the mat-ter much longer."

"What are your prospects as to out-side subscription?"

"We very much prefer having a large majority of our stock held at and near home."

As we were bidding Mr. Hill good-day, and thanking him for the interview, he remarked: "It is hardly necessary for me to remind you that Anderson County ranks second in the State in the manufacture of cotton, and this State ranks second in the United States." We were not thinking of it at the time, but it is a fact that the State of Massachusetts, alone, leads

the State of Massachusetts, alone, leads South Carolina in cotton manufacture.

Mr. Hill is one of Anderson's most savacious and successful business men. All of his business enterprises have been successful, among which was the founding of the Farmers' and Merchants' Bank, of this city, of which he is President. His experience and practical judgment cannot fail to carry to success any enterprise he undertakes, and it is to be hoped that those who have taken an interest in the establishment of this new mill will determine upon making it the largest and best equipped mill in Anderson.




