Death of Mr. John P. Sullivan.

Mr. John P. Sullivan, one of the oldest and most highly esteemed citizens of the city, died at 1 o'clock Saturday night. He had been ill only a few days. He was stricken with pneumonia, and this attack. combined ith a trouble of the heart, hastened

Sullivan was born 73 years ago
oner Township, and was a son of
'e Kelley Sullivan. When the

ears and made a faithful and brave
soldier. He became a sergeant of his
company before the close of the war.
After the surrender Mr. Sullivan returned to Anderson and engaged in
the metcantile business under the name
of J. P. Sullivan & Co. This firm of J. P. Sullivan & Co. This firm continued in successful operation until a few years ago when he retired from business.

Mr. Sullivan was a man of the highest integrity, always upright and sin-cere in all his dealings. He was mar-ried to Miss Lizzie Vandiver, and she, with the following children, survives him: Misses Mary and Meta Sullivan and Robert and Harold Sullivan. A son, J. A. Sullivan, died about two

The funeral services were held Monday afternoon at the family residence, being conducted by Rev. J. D. Chapman, D. D., the pastor of the deceased. The interment took place immediately afterwards in Silver Brook cemetery.

Tragic Suicide of J. K. Breazeale.

Belton, S. C., Jan. 17.—With a rope about the neck, the cold, lifeless body of J. K. Breazeale was found about 2 o'clock yesterday in a barn in the rear of his residence at Belton. The verdict of the coroner's jury, which was summoned later in the evening, declared that the man took his own life.

Mr. Breazeale had been in ill health

Mr. Breazeale had been in ill health for some time. His disease had affected his mind to such an extent that he became despondent and brooded continually over his troubles. It is supposed, in fact, there can be no doubt that in a moment of abject melancholia he decided to end his life and that upon the plan of death by strangulation. Mr. Breazeale left the house about

Mr. Breazeale left the house about 11 o'clock in the morning, and not seeing hus at dinner. Mrs. Breazeale became uneasy and began a search for her husband. She told neighbors of her fears and others joined in the search. After several hours of auxiety, her worst fears were realized when some of the children, who were assisting in the search, came upon Mr. Breazeale's body suspended on a rope, one end of which was fixed in a noose about his neck and the other tied to a beam in the roof of the building. It is supposed that Mr. Breazeale first placed the rope about his neck, then climbed up to the rafters, where he made the other end secure. He then jumped from the timber and in a few moments all was over. Life was extinct. The funeral will take place in Belton this afternoon, and the intertinct. The funeral will take place in Belton this afternoon, and the internent will be in the cemetery. Besides his wife, Mr. Breazeale leaves three children, all of whom are grown, one of them a son, being engaged in business in Texas. He was about 55 years of age, and thoroughly respected by all who knew him. He leaves a large number of relatives, many of whom are in Belton and Anderson County. Mr. Brezeale married a daughter of the late Alfred Campbell.

Bold Robbery at Williamston.

Williamston, January 16.—A bold and daring robbery occurred right in the heart of the town between 12 and 1 o'clock this morning when the post-office building was entered through the front window and the safe containthe front window and the safe containing money, stamps and valuable papers belonging to B. F. Russell, postmuster, was blown to pieces by some explosive and robbed of its contexts. About \$50 in cash and \$75 worth of stamps was secured by the robbers. However, they overlooked \$51 in bills and this amount was found in the debris on the floor of the office this morning. E. M. Lander, cashier of the Bank of Williamston, who rooms across the street within fifty yards of the scene of the robbery, was awakened by the explosion and upon hearing it he went to the front piazza, opened the door and stepped outside of his toom, when he heard a voice at the postoffice building calling the name "Jim, Jim, come on," in very exciting tones, when a moment later three men came hurriedly from the building and rushed down the Southern Railway from town.

Soen afterwards blood hounds were brought over from Pelzer and everything possible was done to strike a trail, but without success, and the robbery seems as much a mystery as if commited by a power of magic.

A hand hammer, evidently the property of some neighboring blacksmith and an old piece of steel buggy spring were found in the postoffice this morning, and it was with these tools that the combination of the door of the safe was broken off, when the explosives were applied to the opening with perfect success.

This is the third case of robbery in exactly the same manner in Williamston during the past few years, and the guilty parties in neither case have ever been brought to justice. The postoffice authorities at Washington have been notified and expert detectives may run these accoundrels in very soon.—Special to Greenville News.

Postoffice Robbers Arrested.

Columbia, Jan. 15 — Christopher, the brother of Rudolph Rabens, both of whom the Federal Grand Jury here yesterday indicted in two cases of postoffice robbery in this State, was arrested in Charleston today deputies leaving here last night for that purpose. Rudolph was arrested in Charleston several weeks ago, but is out on a bond of \$5,000. Judge Brawley has fixed the bond in each of the two cases against Rudolph at \$2,500, so that he will likely not be bothered about his liberty until the Charleston term of court in April, when it is expected that he and his brother will be tried for conspiracy and breaking into and atealing from two postoffices in this State. The Rabens are Charleston German grocers, who went there from Wathalia, to which town they immigrated from the old country. They got into ball company, it is thought through their connection with the old Star Exposition theatre, where they became intimately associated with some swift citizens, both male and female. By the time the case is ready for trial in Charleston, it is likely that a number of other arrests will have been made.
