MASHINGTON, January 12.—The impeachment has taken definite shape since my last letter on that subject to The News, and the inquisition may now be considered duly inaugurated under auspi ces duly Radical. The National Banks get more and more out of humor, and distrustful of Secretary McGulloen every day, and so are constantly casting about for a means of hedging themselves from any possible future reverses that may transpire to their interests by a too rigid emforcement of the pains and penalties attaching to infringement of the National Banking law. Secretary McGulloch is not disposed to look very leniently upon the palpable evasions of the law that are from time to time reported by the Comptroller of the Treasury. Among other provisions of the law for the regulation of National Banks, is one requiring each bank to keep constantly on deposit a sum, in legal tenders, equal to one-fifth of their authorized circulation. About two-thirds of the banks, by their own montbly statements to the Comptroller, are not complying with this provision, and the other third has hit upon the sharp practice of keeping this deposit in their vaults in the shape of compound interest notes, multiplying their principals at the rate of six per cent., and with two or three years to run. Originally, there was about one hundred and forty-five millions of these notes is sued, first in payment of Government employees and portions of the Federal army, only to be gathered up and hoarded eventually by every broker who could lay his hands upon them. Sirty multiples are now half by the New York bapiks alones and what troubles the Secretary of the Treasury is the prospect of having a preponderance of this one hundred and forty-five millions presented to him simultaneously two years hence, compounded with an interest that has grown monstrously during a five years war. There is a Bill now before the House proposing to make the banks surrender these compound interest hosts for redemption in common legal tenders, and this is a cause of nervousness to the banks.
