[SPECIAL DISPATCH TO THE CHARLESTON NEWS.] COLUMBIA, November 7, 6 P. M.—The Conservative State Convention reassembled to-day, pursuant to adjourgment, at noon.

Judge Inglis, from the Committee of Twenty, appointed for the purpose, reported an Address to the People of South Carolina. It is a calm, dispassionate document, describing in pathetic terms the misfortunes of the country and the evils threatened under the present reconstruction programme. It concludes with a respectful protest against the action of Congress towards the Southern States. The tone of the Address is conservative, dignified and eloquent.

Its adoption was opposed on the ground of inexpediency by Messrs. Chesnut, Reynolds, Gilbert, McMaster and Hamilton. It was fa- examination. First, I desire to express to you my thanks for the manifestation of your confidence in appointing me to this position. We have assumed a serious and important duty. We come here from the people of South Carolina; we have met to ex ress opinions upon the condition of the public affairs of our country. In doing so, we should be careful to express them discreetly and with temperance; above all things, with great deliberation. We cannot afford now to commit a mistake. The least feather upon the back of the camel may break him to the earth. We are in a ritical, a perilous, condition, and it behooves all persons to weigh their words with care, and to act with judgment in considering the means whereby the pending misfortune may be alleviated and the threatened evils be removed. Hoping that in the conduct of your deliberations I shall receive the hearty co-operation of every member of this Convention, and that the utmost harmony may mak its proceedings, I now await such observations as may bring the business of the meeting more fully before you. Genlemen of the Convention: In assuming the

REMOVAL OF COTTON UNDER BILLS OF LADING .-The following regulations in relation to the removal of cotton have been issued under the Interna-

Revenue Department: "Under section 4 of the act of July 13, 1866, extton may be removed from the district in which it has been produced to any one other district, without prepayment of the tax, under bond or

without prepayment of the tax, under bond or other security to be prescribed by the Commissioner of Internal Rovenne, subject to the approval of the Secretary of the Treasury.

"It having been found by experience that the furn shing of increased facilities for the removal of cotton without prepayment of tax is consistent with increased security to the Treasury, it is determined to substitute shipments to revenue offitermined to substitute shipments to revenue offi-cers under bills of lading for the bonds heretofore

required. "Accordingly, the owner or other holder of cot-ton which he desires to remove from the district

of the tax.

"The transportation company signing such bills of lading will be required to furnish to the assessor of the district in which is the receiving port sor of the district in which is the receiving port or point of destination, immediately after arrival, a copy of their manifest or way bill, so far as it relates to any otton transported by them, and stating therein whether the cotton is class A, B or C, as hereinbefore required.

"Each assessor will keep an account of all cot-ton entered upon the copies of manifests and way bills so furnished to him.

"Should any transportation company refuse or neglect to furnish the assessor with a copy of manifest or way bill as above required, the assessor will immediately notify all the assessors on the line of such transportation company of such neglect or refusal; and thereafter no permit for the case of the property of the pro bills so furnished to him. transportation of cotton by such company will be granted by any assessor without permission to do so being obtained from the commissioner of in-

ternal revenue.

### Things in Washington.

DISBANDMENT OF MILITIA-COLORED MILITARY COM-PANIES-EFFECT OF GENERAL GRANT'S ACTION. We find the following dispatches in the Baltinore papers of Wednesday.

The announcement in these dispatches this morning that the President had issued an order to General Grant to have armed military organizations in the District of Columbia disbanded created quite a stir in this community. In the early part of the day speculation as to whether General Grant would execute the order took possession of the quid nuncs, but when it became known at a later hour that the General had not only given proper directions to his subordinate officers to carry out the Executive flat, but likewise admitted the illegality of these organizations, public opinion settled down into something like astonishment at the sudden disbanding of the militia companies and the promptness with which the order was executed.

### ry occupation is gone. IMPEACHMENT REPORTS.

The Judiciary Committee, both majority and minority, will have their reports ready to submit to Congress on Thursday, the 21st inst. The majority report will be against impeacement, and it will be signed by the same members who voted nay in the Committee on the 8th of June last. The minority will be alessrs. Boutwel, Lawrence, Williams and Thomas, as heretofore. Both sections of the Committee are agreed upon one Williams and Thomas, as necessary upon one tions of the Committee are agreed upon one point—that this question must be immediately de-cided, and it will probably be the only business of the few lays that will remain of the first session of the Fortieth Congress. Hon. James M. Ashley, the chief of the impeachment movement, arrived in the city to-day.

General Grant was engaged at the War Department up o noon to-day (at which time he attended the Cabinet meeting) upon his report. The statement made by one of our cotemporaries that his report had been finished and sent to the printer is erroneous. He expects to have his report prepared by the 20th instant for the use and information of the President. The reports of the various Department Commanders, and Commissary, Quartermaster and Paymaster's Departments have been received by General Grant. His own report as Commander-in-Chief of the Army, and his report as Secretary of War ad interim, will both be very brief. It is stated that he advocates quite a reduction of the army, and the expenses attendant thereon. GENERAL GRANT'S REPORT.

### NO INCREASE OF TROOPS

It is learned offic ally that the Government does Not intend to increase the millitary force in the Southern States—the telegrams in the Northern press to the contrary—nor has General Grant any information of any contemplated insurrection in the South, as has been published.

FINANCE AND TAXATION. The Washington correspondent of the New York

Commercial Advertiser writes:

Whatever may be the moves on the political chess-board, it is certain that Congress will be compelled, by expressions of public opinion not to be disregarded, to take up, and to dispose of the great financial questions of the day. A return to specie payments at an early day will be urged and opposed, and the subject will doubtless be definitely settled during the early part of the coming year. Meanwhile the reduction and the equalization of taxation will be brought forward, with the proposed changes in the tariff of duties on imports. The improved adminis ration of justice by a codification of the Federal laws will also be before Congress, and there will be grave subjects of foreign policy to be discussed. But finance and taxation are to be the prominent questions, and in their definite settlement all business Commercial Advertiser writes:

nance and taxation are to be the prominent questions, and in their definite settlement all business men and manufacturers are interested.

It has been a just subject of complaint during late years, that the Tariff and Tax Bills have been kept back until so late a day that hurried legislation was inevitable. Thus, of course, gave an excellent opportunity to "manipulators" to look out for their little interests, and large sums of money have consequently been made at the expense of the public. This year several representatives have announced their determination to insist that all important bills shall be reported at an early stage of the session, that they may be printed and distributed among the people some weeks before tributed among the people some weeks before they are considered. This will give all interested an opportunity to have their views presented here.

THE BUREAU BEPORTS. General Howard's premature publication of his report as Commissioner of the Freedmen's Burcau of the War Lepartment, has subjected that gallant officer to much criticism. The reports of Burcau officers are made o the Secretaries at the head of officers are made o the Secretaries at the head of their r. spective depar ments, who in turn communicate them to the President. Meanwhile the reports are to be confidentially printed, that they may be laid before Congress at the commencement of the regular session. It is not many years since the Chief of the Signal Bureau was suspended, if not dismissed, for the publication of his report before it had received the sauction of the Secretary of War, and had been by him officially made public. If every subordinate official hastons to place his report before the public, the reports of the Secretaries, and the message of the President, which are based upon them, will be uninteresting documents.


