The only news of interest I have to communicate is the gradual downfall of the Emperor. He has been going dow thill very rapidly during the last two months, and should the same state of things continue much longer, we may never see his face again, as he will hardly venture so far with he disaffected soldiery. For the last four months he has only been able to communicate three times with the garrison here, and even then hal to employ a servant of one of the native prisoners confined in this fort, fearing that one of his own people might be waylaid and murdered. There is now nothing but death between the prasanty and their late ruler. If any of the former fall into the hands of the latter, they are instintly burnt alive or burbarously mutilated, and left to die a lingering death. On the other hand, whenever any of the royalists fall into the hands of the peasants, they are forthwith backed to pieces. I have, managed to communicate twice with Mr. Flal, at D.b.a Tabor, but on each occasion my messenger was stripped naked on the road. Mr. Flal gives me a sad account of the state of affairs in the royal camp. Nothing but destruction of life is going on there from morning till night. The whole country between Debra Tabor and the Lakes, which formerly was thickly populated, has been laid waste, and all the inhabitants, men, women, and children, who could not effect their escape have been ruthlessly murdered. The garrison at Debra Tabor has been surrounded with a hedge, and if a soldier attempts to desert, his wife, children, and other relations he may have are instantly butchered. A body of 2,500 men who attempted to decamp last month were slaughtered like so many sheep, and 295 chiefs were left to die of starvation, after suffering the mutilation of their hands and feet. Ladies, too, of noble families, after being a riped to nudity and exposed to the gaze of the soluery, were tortured and thou executed. 

"GOOD SAMABITAN."

THE PHILADELPHIA UNIVERSITY OF MEDICINE by the Legislature February 28, 1833. Name changed by a legislative enactment to the Eclectic codical college, or Philadelphia, in 1860 in 1863 it purchased the Pennsylvania Medical College, es ablished in 1342, and the Philadelphia Medical College, which had previously been merged into the Pennsylvania Medical Univ.rsi y. In 1864 it purchased the Penn Medical Univ.rsi y. In 17 trustees of the separate schools united, petitioned and obtained a special act of the Legis ature, consolidating these institutions and oha ging their names to that of the Philadelphia University of Medicine and Surgery, starch 15, 1865. All these various acts are published in the statutes of Pennsylvania. The cost of the !uliding and museum was over one hundred thousand dollars. It will be observed that the University, as now organized, is the legal representative of the four Medical Colleges that it has absorbed. It is a liberal school of medicine, confined to no dogma, nor attached to any medical cliques, but embraces in its teaching everything of value to the profession.

profession.

Serionz.—It has two full sessions each year, commenoing on the lat of October, and continuing until the lat of January, as its first session, and from the lat of January to the lat of April, as its second; the two constituting one full course of lectures. It has also a summer session, commencing the lat April and continuing until August, for the proparatory branches, such as Latin, Greek, Mathematics, Botany, Zoology, Chemistry, Anatomy Physiology, etc. Physiology, etc.

To aid young men of moderate means, the University has issued five hundred scholarships, which are sold to first-course students for \$50, each constituting the holder a life member, with the perpetual rivileges of the lectures, and all the teaching to the school. The only additional isses are a , early dissecting and matriculating ticket, each of which is \$5.

The Advantages of Scholarships.—The student holding a scholarship can enter the College at any time during the year, attend as long as he chooses, and re-enter the instinution as f.equantity as de-ired.

It requires no previous reading or study to enter the University on scholarships, hence, all private tuition fees are saved.
