Resotted, That we, the Irish and friends of Ireland, of Charleston, S. C., deeply regret and deplore the sad fate of our brothers in England; we heartily sympathize with the families and relatives of those noble men, in this their hour of affliction, but we ask them to be of good cheer, as the Almighty God, with all His mercies, will not forsake them that suffer for righteousness' sake.

Resotted, That the English Government by unjust legislation, has deprived the Irish people of the right of freemen. Many of us left the land of our fathers on that account, but found a refuge under the expansive fold of the American flag, which we have sworn to defend under any and all circumstances, and to oppose all foreign powers.


