NEWS SUMMARY.

—Gold closed in New York on Saturday firm at 138 1/4.

—Cotton in New York on Saturday was active and excited; sale better. Sales 12,000 bales, at 26 1/2c, closing quiet. No buyers over 29 1/2c.

—In Liverpool cotton closed on Saturday active and excited, at a further advance. Sales 30,000 bales. Uplands 10 1/2c.

—The Irish population of New York is two hundred thousand.

—Württemberg has chosen delegates to the Congress of the Zollverein, who are opposed to the policy of Prussia.

—A slight shock of earthquake was felt at San Francisco on Tuesday, causing considerable excitement, but no damage.

—The steamer from San Francisco for Panama this week has \$3,000 in treasure and 2500 barrels of flour for New York.

—The farewell readings of Mr. Dickens in New York, are announced. On Wednesday, April 23rd, Mr. Dickens will sail for Europe.

—The Epsom (English) races commenced on Wednesday. Bluebird won the Metropolitan stakes, and Clarence was the winner of the Prince of Wales stakes.

—Hon. J. M. Davis and lady left Baltimore on Tuesday evening, by railroad, for New York en route to Canada, there to await the next call for his trial.

—Governor Fenlon, of New York, has finally decided to refuse a pardon to Edward B. Ketchum, the young millionaire, Wall-street gold-broker, and defaulter.

—Mr. Stanton has now been enduring self-imprisonment in the war office for over one month, and still continues to hold out in his determination to remain till the Senate has disposed of the President.

—Heretofore no colored persons received tickets of admission to the impeachment trial, but it is now stated that Senator Sumner has issued tickets for the admission of one colored gentleman and two colored ladies.

—One of the *ditto* affairs in Washington is that the President's counsel will summon one hundred prominent lawyers, of both parties, to testify upon the legality of the tenure of office law.

—A project is under consideration in London to establish telegraph communication from England to India, China and Australia, by submarine cables. The government will be asked to assist the enterprise.

—Ben Wade is rather ashamed, after all, of his intention of voting himself into the Presidency, and swears—literally swears—that he will kick anybody down stairs who comes to ask an appointment before he is fairly in.

—Telegraphic communication can now be had directly with Havana. The wires have been laid from the coast to the city of Havana, and carried up to the palace of the Captain-General.

—The division of Texas into three States is a measure said to be determined upon in Congress. This will be done in direct opposition to the will and wishes of the people of that State. The sole object is to add to the representation of the Radical party in Congress.

—The Democratic majority in Harrisburg, last Friday, was four hundred and forty-six, against one hundred and eighty-four last fall, and they elected all the councilmen. Lebanon, Pa., went Democratic, on Friday, for the first time in two years.

—A Liverpool shipping firm, it is announced has given free passage to about 350 Irish persons, of both sexes, to Rio Janeiro, where they will get land at a shilling per acre, and have five years to pay for it. Brazil has over fifty foreign colonies within her borders, with about 70,000 colonists, chiefly Germans.

—Maximilian's bondholders in Paris recently held a meeting, at which it was stated that the total amount of their loan to his short-lived empire was \$58,283,424 in gold. This they think the French Government ought to pay, as it set up and guaranteed the Empire in Mexico.

—Women are steadily gaining a foothold in pursuits heretofore restricted to men. On Monday evening the commencement of the New York Medical College for women was held, and in the presence of a large audience, eight ladies received diplomas of graduation, the address in presenting the diplomas being made by a lady, Mrs. D. C. Lozier, who is dean of the college faculty.

—The steam train that has made so much talk is now denounced by a Newark man, who seems to understand the case, as an unmitigated humbug. It never has walked a step since it was made. It was carried from the shop where it was made to an ice-cream garden; then it was propped up, and so that its feet did not touch the ground, and set agoing. Its legs swung back and forth in the empty air, and that was all.

—Forney grows bolder as impeachment advances, and charges the President with "supreme audacity in asking delay upon the frivolous excuse of preparing to defend himself." He furthermore announces that the "case is made up and disposed of," which may be honest, but is certainly disgraceful in any one—but Forney.

—Grant is said to be afraid of Butler since the latter loomed up as grand panjandrums of impeachment, and to regret the epithet of "bottled," which Rawlins and Badeau put in the General's mouth. A correspondent says: "Grant and Butler speak to each other, and Grant never refuses any request that Butler may make; but the old bald scowl is a long hair."

—Queen Victoria held a "Drawing Room" at Buckingham Palace on the 19th inst, and it is again noted in the Court Circular that the United States Envoy was absent from unavoidable circumstances. The "unavoidable circumstances" are the absurd law of Congress, prohibiting our foreign ministers from wearing usual dress upon state occasions, and Mr. Adams was too much of a gentleman to intrude in costume which was not appropriate to the occasion.

—Advises from Mazatlan, Mexico, report that there was fighting going on in the streets of that Mexican port between the government forces and a party of insurgents under Martinez. The latter claims that before next summer a new republic will be established from

Malamoras to Mazatlan. Lopez, the betrayer of Maximilian, has been imprisoned in Mexico. The Mexican judiciary denounce as unconstitutional the law under which Maximilian was tried and executed. The Mexican clergy refuse to confess patients in consecrated convents.

—A duel took place in New Orleans lately between two Creoles, which is described as a very desperate encounter. The weapons used were French navy broad swords whetted up to keenness. The parties were experts, seconded by equally good swordsmen. The combat lasted a few minutes only, when one constant received a cut over the right temple and the other a serious wound in the left wrist in his successful endeavor to ward off a deadly blow of his adversary aimed at his abdomen. The combat was then arrested, and the wounded parties received attention of their physicians. The floor upon which this desperate duel took place was literally covered with blood, which flowed in great profusion from the wounds of both combatants. The cause of the duel was of a personal character and for a wonder no lady was connected with the affair.

The Proposed Convention.

It is proposed to hold a convention at Columbia on Thursday next to consider, it is presumed, what is necessary to be done for the well-being of the State and the avoiding of the manifold dangers with which this people is threatened. This proposition, however, is open to the grave objection that, if held at the time suggested, it cannot represent, in the true sense of representation, the feelings, determinations and desires of the citizens of South Carolina. No sufficient time has been allowed or warning given, and if the convention be held on Thursday it cannot reasonably include delegates from this district or from many other districts in the State.

The convention, however, held, should be composed of delegates chosen deliberately by the people of each district, and who are fully acquainted with the wishes and intentions of their constituents. It should be above mere party names, and, while avoiding those irritating questions in which there is more of idea than of fact, should so behave as to retain the confidence of the whole State and secure the hearty co-operation of every conservative man within our borders. This is necessary because only a united and persistent action, in a well defined manner and direction, can work any lasting benefit or give to right any substantial protection.

This is no time for rash or hasty measures,—for thinking one and acting twice, for the scheming of disappointed politicians, for the dogmatism of hereditary malcontents, for the clamor of those whose page is war eternal. It is a time, on the contrary, when the people may, and should, take counsel together, in which they may meet to consider where lies the division between custom and principle. It is a time, above all, when the people should be sober, prudent and just, behaving in all things with a dignity, a forbearance and a calmness worthy of them and their cause.

The President's Fate.

The preliminary moves in the matter of impeachment have been completed and today the trial of the President will begin in earnest. The result is not doubtful, nor will it be long delayed. It is a predetermined fact that the President is to be thrust out of office and Ben Wade there in. Nor is this all. Under the Wade regime, it is authoritatively announced, the number of Judges in the Supreme Court will be raised to thirteen, thus relieving the Radical mind for the future of all apprehension in regard to that adverse majority which has haunted it for months past. The remedy is certainly simple, and will unquestionably prove effectual, but how the country will regard this method of "stacking" the highest tribunal in the land is hardly a matter of doubt. Measures like these can but hasten the retribution, certain though long deferred, which awaits the party and its leaders, who are now in power.

The National Finances.

While the Radicals seem to have matters, politically, all their own way at Washington, the more far-seeing among them are showing unmistakable symptoms of alarm at the plight to which their party policy has already brought the finances of the country. The demagogues who rule upon the floors of Congress, having in view the coming Presidential election, seek by every expedient, and at whatever cost, to make political capital for themselves by temporarily relieving the people from taxation. Secretary McCulloch has vainly remonstrated against these time-serving measures, although his views are sustained by some of the shrewdest of the Republicans. Senator Morrill, who was, it will be remembered, the Chairman of the House Committee on Ways and Means during the war, regards Mr. Sherman's exhibit that the deficit will not be over \$16,000,000 at the close of the fiscal year 1868-69, as fallacious. To bring it down to that, Mr. Sherman has estimated the receipts from the whiskey tax at \$50,000,000, and has placed the receipts from the latter loomed up as grand panjandrums of impeachment, and to regret the epithet of "bottled," which Rawlins and Badeau put in the General's mouth. A correspondent says: "Grant and Butler speak to each other, and Grant never refuses any request that Butler may make; but the old bald scowl is a long hair."
