The Free Schools of Charleston-Their Past. Present and Future

The free schools of Charleston will compare favorably, in every respect, with those of most Northern cities, and they confer credit both upon the State and upon the individual who inaugurated the present excellent system. To Mr. Jefferson Bernett is mainly due the pleasing result that has been obtained in the matter of public education. He saw the necessity of a new development, and for nearly fifteen years devoted himself steadily to this one great object. He was influenced by no hope of reward or political preferment, but simply labored for the good of his State. Under the old regime the free schools in

the city were generally located in dark and narrow lanes or in some almost inaccessible place. For many years one of these schools held its sessions in a house built on piles in the marsh at the eastern boundary of the city. At high tide it was surrounded by water, and at ebb by the marsh mud; it was connected with the main land by a bridge, and, notwithstanding the ineligible location, was used for a considerable length of time. This marsh ble one, as the school buildings were generally was customary to pay the teacher a fixed amount of money, out of which he would pay the rent of a school house, the residue being his fee or salary. Although there were eight or nine of these schools in the city, the attendance was generally small, and the very name this line in Paris, has made its appearance in of "free school" became distasteful to the peoschools. The Meeting-street school house stood as the sole redeeming feature of this and was, curiously enough, intended to be the model school building of the city. But it had originally only two large rooms, in which all of the scholars were taught. Class rooms were then unknown, and the more noise the pupils made in their recitations the more diligent they were presumed to be. Notwithstanding the deficiencies in the free school system of that day, it was not without some redeeming qualities. It was the best that could then be furnished and, possibly, a lack of appreciation of the advantages of general education prevented any efforts for a change.

After years of patient waiting, Hon. C. G. Memminger, Mr. Lennett and Judge Magrath, all firm friends of edrcation, succeeded, in December, 1854, in obtaining an appropriation from the legislature, and a new board of school commissioners were elected. This board went into office on the 22d of January, 1855, and immediately commenced operations.

THE ST. PHILIP'S STREET SCHOOL was the first built, the board having granted the contract on the 7th July, 1855. The buildings formerly occupying the site were removed and on the 25th of June, 1856, the new school house was opened to the public. number of applicants at the last term. THE NORMAL SCHOOL,

in St. Philip-street, was the next erected. Authority was obtained from the legislature in 1857, the contract was awarded on the 12th of July, 1858, and the school opened on the 23d of May, 1859. This was designed as a high school for young ladies who had finished the course of studies in the other school. Mr. F. A. Sawyer was chosen principal, and, until the war, this school was perhaps the best patronized in the city, many young ladies of position attending its course. The instruction was thorough and complete, embracing, besides the English branches, French and drawing, and the graduates were fully competent to assume the duties of teachers, if so disposed. It was opened with fifty-one pupils, but this number rapidly increased. When the schools were reorganized, Mr. H. M. Mood was elected principal, and continued to act in that capacity, charging a small tuition fee, until a further change was made by the commissioners, and a free school esablished, when Miss Anna M. Simonton was appointed principal. At present the school has eleven teachers and ten classes, and four hundred and seventy-two scholars, with an average attendance last month of three hundred and seventy.' . The teachers are all ladies, most of them being graduates of the institution. The studies, as yet, embrace only design, in time, making the school what it was in the past.

THE FRIEND-STREET SCHOOL was contracted for on the 26th July, 1858 and was opened on the 23d of May, 1859. The other schools had become crowded, and it was found necessary to open another in the lower wards. This school was well attended and in a prosperous condition until the disastrous fire of 1861, which swept over that portion of the city, and laid the structure in ruins. The depressed state of the country has prevented the commissioners from rebuilding, but they have since purchased an adjoining lot, and increas-

STATISTICS. The average attendance in all of the schools last month was seventy-six per cent.; in the white schools seventy-nine per cent., and in the colored sixty-eight per cent. This low average was caused by the number of rainy days in February, when only a few scholars were present. The property owned by the Board of Commissioners consists of the different school houses mentioned, with the large lots attached, and two houses at the corner of Beaufain and St. Philip streets, adjoining the Normal School lot. Each of the school buildings cost about \$30,000, and the present total value of the property is estimated at \$100,000. The furniture and material used for educational purposes are of the most approved style and pattern, while the buildings are large, commodious, well ventilated, and admirably adapted to their

THE BOARD OF COMMISSIONERS was elected at the last session of the State Legislature, and consists of the following gentlemen: C. G. Memminger, chairman; C. M. Furman, W. S. Henery, C. H. Simonton, Beniamin Lucas, W. A. Pringle, F. A. Sawyer, W. J. Bennett, F. Richards, J. Russell, P. J. Coogan, Henry Buist, and E. M. Grimke, Secretary. Committees of these commissioners have been assigned to each school, and a general superintendence is exercised. Mr. Jefferson Bennett, to whom these schools owe much of their present prosperity, declined to serve, and another gentleman was elected in his place.

THE PEABODY FUND. The magnificent donation of Mr. George Peabody has been well applied by the commissioners in charge. Dr. Sears, the visiting agent, is now in the city, and attended the teachers' school last Saturday. He has exwith the general management of the schools, and thought there could be no better mode of fulfilling the wishes of the donor than by awarding them a portion of the Peabody fund. One thousand dollars has already been received by the commissioners, and this will be followed by further advances as the interest of the fund accumulates.

THE FUTURE of these schools is doubtful. We have fallen upon strange times, and our "lines are not cast in pleasant places." The new rulers of the land appear to have the full control, and what they dictate will for the time be law. Indiscriminate huddling together of whites and blacks would, however, cause the ruin of the public schools, and reduce them to a condition in which they would be neither honorable, serviceable nor advantageous.


