THE IMPEACHMENT-THE FINAL RESULT STILL IN DOUBT-INTENTIONS OF THE MANAGERS.

impeachment continues to abate, although the contest for the votes of doubtful senators on the second article is still waged, and there is renewed confidence among the impeachers that this article may yet be carried, but the ground of such confidence does not well appear. Some of the managers are confident that the investigations in which they are engaged will greatly help their case, but the calmer and more dispassionate members of the committee do not agree with them. Should corruption be proved, a new article will be presented and the managers will as a that the court be purged. The National Intelligencer

The managers are said to be much at fault what course to pursue in respect to impeach ment. It is said that General Butler is of opin ion that the best course is to take the vote or ion that the best course is to take the vote on Tuesday, as fixed by the present order of the Senate, with a view to separate the impeachment sheep from the non-impeachment goats. Others advocate a postponement, so as to hold the sword over the President's head with a view to coerce his action; and others still propose a new or twelfth article, on which they will have to vote the carpet-bag senators from the South, about to be brought in under Mr. Trumbull's auspices. Some of the Radicals affirm and protest that impeachment is not dead, but only sleepeth until Tuesday next, when the Second article, say they, is sure to be carried. But the almost unanimous opinion is that impeachment /has utterly failed, and this chment / has utterly failed, and this nas induced many to drop Mr. Wade, upon the popular theory of assisting a man in his progress down hill. The opinion of good judges is, that the future policy of the impeachers will depend, largely on the development at Chicago, where great efforts are being made to smother up the differences in the Republican party.

Witness professed to doubt his authority, and the person then brought a letter from Senator Pomeroy, dated "Senate Chamber, — day of —," as follows:
Sine—I will, in good faith, carry ont any arrangement made with my brother-in-law, Willis Gaylord, to which I am a party.

(Signed) S. C. POMEROY,
United States Senator.

General Butler objected to witness proving the contents of the letter, as he [Butler] could produce the letter.

Willis Gaylord was introduced by the person first calling. The letter was read to witness and Gaylord by the person, who then retired, when Gaylord renewed the proposition, that for \$40,000 cash, and the distribution of patronage, the five Republican votes, including Senator Pomeroy's own, would be so cast as to insure the acquittal of the President. The witness believed at the time the proposition was intended to entrap him. Witness assigned as a reason for this belief that Senator Pomeroy was a strong partisan; that he felt bitterly towards the President, and that if money was his object, the party to which he belonged was better able to pay than the friends of the President. Mr. Samuel Ward, of New York, was next before the managers. He was supposed to be aware of attempts to buy votes for acquittal, but his testimony tended to disclose rumors of efforts to buy up or influence votes for conviction, and nothing indicating knowledge of efforts to procure votes for scupittal.

SPEECH OF EX GOVERNOR JOS, BROWN, OF GEOR

GIA-A FULL POLITICAL CONFESSION. We give below some extracts from the report of the speech of ex-Governor Brown, of Georgia, which was briefly mentioned in our tele graphic report of the first day's proceedings of the National Republican Convention at Chicago. Governor Brown having announced himself as "reconstructed rebel," and being invited to the platform to "give his experience," said:

As I remarked before I left my seat, I was an original secessionist, I was born in South Carolina. Growing up under the influence and teachings of that master intellect, Calhounthen in the full glow of his meridian—I eagerly imbibed his States' rights doctrines, and I suppose that I sincerely and religiously believed that they were correct, as you believed that your opposite views were sound for years before the unfortunate struggle we have passed through. I forests the issue which before the unfortunate struggle we have passed through. I foresaw that the issue which divided North and South must ultimately be settled by the sword.

I went into secession cordially. As a States' rights man I stood by it—[cheers]—as long as there was any chance to sustain it. When the President of the Confederate States abandoned the great States' rights doubting that we com-

menced and were agreed upon, I differed from him. When he adopted his conscript measures, which gave him the entire control of the whole army of the Confederate States, and of every officer in the army—an error, sir. you whole army of the Confederate States, and of every officer in the army—an error, sir, you did not commit—I took issue with him. But we went through the struggle, and I will not attempt now to renew its history. But we of the South fell; you of the North were the conquerors, and I think I had sense enough at the end of the struggle to know when I was whipped. [Cheers, I

the struggle to know was Cheers. I As I understood the doctrines of Democracy they were State sovereignty and the right of secession. The sword has established a different doctrine, and hence it is that I am no longer bound by allegiance to the Democratic party. The Hamiltonian and Websterian construction of the constitution has been established by ion of the constitution has been in that, and the sword, and I have acquiesced in that, and I find the Republican party standing on the platform to-day that has been abandoned by the Democratic party. That naturally leads the Republican party. [Cheers.] I into the Republican party. I tall you. me into the Republican party. Unleast, it know that it is a very impopular doctrine in the South, but I believe it is true. But I tell you, Mr. President and gentlemen, that there are many white men in the South, there are large numbers of original Democrate there, large numbers of original secessionists in the South, who to-day stand as firmly by the Republican party and will support the great captain of the party and will support the great captain of the age, General Grant. ## THE COTTON SUPPLY.

(From the Boston Post.) How much cotton remains in the country The stocks held by manufacturers would supply their consumption at a full rate for periods varying from four weeks to five months, averaging about up to July 15. The rate has been reduced and is reducing weekly. If now 14,000 bales per week and soon to be 12,000 or less, the stocks in hand can be made to extend to August 12, or a later average. A supply of old c otton is required with which to run up to Oc-tober 15, say thirteen weeks if from July 15, or nine weeks if from August 12. For thirteen weeks at 15,000 bales per week, 195,000 bales or for nine weeks at 13,000, 117,000, of which quantities the latter is likely-to exceed the requirements up to the incoming of new crop cotton. To supply it, there are stocks (on hand and on shipboard) in markets-

The minimum quantity, 117,000 bales, has been allowed for. The stock then to remain, 108,000 bales, would supply enough to make good the possible maximum requirement, and still leave in the ports quite as much cotton as dealers will be willing to hold for the chances of market after October 15.
