DENTALLY SEOT BY ONE OF HIS POSSE .- On the night of the 3d instant, several prisoners sitceeded in effecting their escape from Charles-ton jail. Among the number were a white man named Wall and two colored men, who confined under charge of murder. These left for their homes in Gillisonville, and the Sheriff of Colleton was telegraphed immediately to look out for them. Two of the United States detectives were also sent down to Gillisonville, and on last Wednesday the Sheriff organized a posse and went in search of Wall and the other escaped prisoners. They were tracked to Wall's house, and the posse aurrounded it, for the purpose their escaps. Wall had, howded in obtaining some inkling of the pursuit, and the inmates ran from toward the swamp. The Sheriff's posse endeavored to overtake them, when one of the posse, a colored man, who had been entrusted with a gun, fired at the prisoners, but mistook the Sheriff, who was somewhat in advance, for Wall, and the former functionary received a full load of buckshot, inflicting a severe but not dangerous wound. The prisoners made no determined resistance, but were soon rearrested and taken to jail. The shooting of the Sheriff was represented as entirely accidental, the posse being thrown into some confusudden escape of Wall and his confreres from the house.

THE CONTRAST BETWEEN NOW AND THEN-A LIVE SPIRIT AT WORK-HOW IT PROGRESSES -WHAT HAS BEEN DONE AND WHAT RE MAINS -THOUGHTS FOR THE THOUGHTFUL, &C., &C.

One of the most remarkable features of our city experience, which daily strikes the eye of the observer, is the contrast between Charleston as it is to-day and as it was at the close of the war. Then more than half of Charleston was deserted. The old men were refugees, the young men were in the field. Business houses were closed, and the very signs read like obituary notices of the dead or absent owners. The wharves were crumbling to ruins: the streets had given up their pavements to build fortifications, and on all sides might be traced the embroidery done in shell work by the ar-istes of the rederal General Gilmore. Silence reigned supreme save when disturbed by the monotonous tramp of the Federal soldier as he kept watch over the recently captured strong

By and by the wave of business began to recede from the up-town rookeries to the downtown warehouses. From army, bomb-proof and country village, the young and old came flocking back. There was little money; but now and then the results of an unbroken credit cropped out in some handsome stock of merchandise, and business once more resumed. By degrees all found a place in the picture. Cotton came to light from a score of hidden recesses, and was turned to gold. The mechanic found ample work to do, and a living compensation. The merchants vied with each other in the general scramble for patronage, and "quick sales and small profits" was the motto of the day.

There were broken hearts and ruined homes empty pockets and famished wives and little ones; there were thousands who before the close of the struggle knew nothing of want and misery; but externally in her local features the city wore an air of convalescence. The streets were repayed; the public institutions were again ned; banks were established; rows of offices nd stores made Broad-street and the Bay look not unlike the beehive of former times; the Battery was beautified, and once more made attractive; several steam fire engines were introduced, in addition to the one made at home; a city railroad was constructed; lines of steamships began to ply to and from the great seaport of the North; the railroads were rapidly repaired; men of wealth came hither, bringing wealth and capital some stayed; tourists visited the "City by the Sea" that had been made historic, and left their greenbacks, and progress and prosperity seemed, for a while at least to have marked Charleston for their

Looking back upon those flours from the resent standpoint we have no reason to complain that the spirit of progress has been materially interrupted. On the contrary, not-withstanding the depression of trade incident to a small cotton crop, bad debts, and unpaid loans, we have moved steadily forward until the contrast between 1865 and 1868 has become marked and well defined. Under the administration of Mayor Cogswell, especially public improvements have been made with a rapidity and dispatch, and attended with an economy that has left no room for cavil or complaint. Broken sidewalks, which, for months, were an eyesore, have given place to smooth, handsome asphaltum pavements, whereon it is a pleasure to perambulate; the streets have been relaid; a shell road is in process of construction and woll-nigh completed, which will constitute a daily attraction to every owner of a vehicle who loves the country air, which he may find

in a half hour's drive.

A new system of cleaning streets by contract has been adopted and nearly twenty thousand dollars saved to the tax-payer, besides the additional security given to health and life. The lower guardhouse has undergone a purification and adornment, which makes it the temple it ought to be-that, too, without a dollar of expense to the city, the cost of repairs being paid from the fines exacted from the ffenders names, and were organized as follows:

As an accessory to the drainage of the city in that part of Charleston, the improvement is most desirable. This scheme, however, can well afford to be held in embryo, but some time it will undoubtedly be perfected.

An effort will probably be made to make a direct route from the depots to the Bay, more 'navigable" than at present, so as to divert a portion of the heavily laden drays from Meetng-street, and save horseflesh and power. It has been suggested that a layer of sawdust mixed with the sand would make a good road

for the purpose. An improvement that may hereafter engage the attention of practical men is the concentration of all the butcher pens on the stream that makes up to Gadsden Green and the Potter's field from the Ashley River, so that the offal can be carried away by the tides.

The great difficulty, however-and one that eems almost insurmountable, owing to the peculiar topography of the city—is in providing a thorough system of drainage. In many of the streets, notwithstanding the care and expense bestowed upon them, the green mould that has accumulated along the gutters and upon staguant pools shows too surely where disease and death begin their work. The filth of poor neighborhoods is in some measure the cause, perhaps the chief cause, of this condition of things, and, in the absence of any known cheap mode of effecting a change by the skill of the engineer, police regulations may possibly enforce the cleanliness desired.

There are many improvements in the mind's eye of pregressive men who have the advanceent of the city at heart, and one day they will be developed. We have contented ourselves with a simple review of "things done," and ing, it is not now a matter of general informasketching briefly the things that "may be."

BILL TO EXTEND THE LIEN FOR CITY TAXES. Be il Ordained, &c., That hereafter taxes shall constitute a specific lien on the property taxed from the time when the liability for the said taxes accrues, and such taxes shall be paid prior to and in preference of all judgments, mortgages, pledges, debts or other liens of a pri-vate character on said property.

Alderman W. said he offered the above bill because no provision existed upon the subject, and a case had arisen in which the court decided adversely to the city in the collection of taxes which had been standing for more than one year, as would be seen by the following letter from Hon. W. D. Porter:

CHARLESTON, June 16, 1868. Colonel M. Cogswell, Mayor.

Sir: I enclose you a certified copy of the decision of the Appeal Court in relation to city taxes. The substance of the decision is that as against mortgages, judgments or other liens of prior date, taxes are a preferred lien only for the period of one year. This does

not release the owner of the property from lia-bility—it only postpones the lien to others of

Under this decision it will not be advisable for Council to defer the collection of taxes beyond the year in cases where there are prior liens upon the property.

Should Council desire to extend the lien for taxes and give it a preference to all other incumbrances, I enclose draft of a bill for that purpose. And I am of opinion that Council, in view of the necessities of government, has the authority to establish such priority of lien as against all private incumbrances. authority to establish short places.

I also enclose the bill of Clerk of Appeal
Court for copy of the decree.

Alderman Geddings. It has been the hope of those interested in the subject that we could meet the interest upon the debt of the city past due, amounting to about \$39,000, but I find that it cannot be done, except in the ordinary stereotyped way. I find that we have a floating debt of something like \$50,000, upon which the city is paying heavy interest. It is desirable that we should meet, as far as possible, and as promptly, the potes outstanding, so that we ble that we should meet, as far as possible, and as promptly, the notes outstanding, so that we may get all the collaterals in our hands, to be used in case of any energency that may arise. The only manner in which this can be done, however, is by funding the arrears of interest, and I have, therefore, prepared a bill in the usual form for this purpose.

[Alderman Geddings here introduced the bill, which was read the first time. It is the same text that has been heretofore published in THE NEWS, and as the blanks are to be filled by dates and amounts on its second read-

Alderman Clark introduced the following, which was read the first time: Whereas, in the management of the City

Government it is the imperative duty of Coun-cil to so closely watch and guard its finances that the expenditures shall not exceed the re-

ceipts;
And whereas, it is well known that our present expenditures of City Government are in excess of its receipts, be it
Resolved, That a special committee of five be appointed by his Honor the Mayor to report to Council at the earliest practicable time port to Council at the earliest practicable time a system of taxation and exponditure, by which said desired end can be attained.

M. Mayor and Aldermen—In introducing this resolution, some explanation is necessary.

The fact is patent to all tax-payers—and who in this city are not?—that, although severely taxing the people, the city is not paying the interest on its debt, and scarcely paying its running expenses. It is well known that there is, or will be at the expiration of this year, a deficit of nearly \$300,000, which is practically the interest on her debt of \$5,000,000, at 6 per cent. per annum. Without attempting to trace out the causes of this enormous debt, or the reasons for this large deficit, let us take hold of this monster of responsibility as it is, and prevent its future unmanageable accumulation.

And, gentlemen, let us thoroughly understand to what dangers this \$300,000 deficit, if allowed yearly to be piled up with its interest, would inevitably bring us. Starting with a debt of \$5,000,000, in twenty years the entire real estate of the city, now assessed at \$20,000,000, would be absorbed; but long before the lapse of that time, in say ten or twelve years, as "rats leave as sinking ship," so will our inhabitants leave us with what property they can carry, and bankruptey or repudiation, with all its attendant evils. will hold those remaining.

Can the interest on our city's debt be regularly and promptly paid? Can the daily and yearly and promptly paid? Can the daily and yearly and promptly met? As an answer I use the simple and expressive word—yes!

A system of taxation can be inaugurated by and expressive word—yes!
A system of taxation can be inaugurated by which many—the business men and those connected—who are now too heavily taxed, will be

which many—the dusiness men and those connected—who are now too heavily taxed, will be
relieved, and none will be more oppressively
burdened than they now are.

A system of expenditure can be inaugurated
by which many evils as they exist will cease,
and large amounts may be saved, instead of
being, as far as the city is concerned, squandered and lost.

Yes, gentlemen, a system of taxation and
expenditure can be inaugurated, from the
benefits of which the widow, the orphan, and
all dependent upon city interest, shall have
something besides a shadow to lean upon—a
system by which our stocks and bonds shall be
brought up to where any six per cent. stock
ought to be; in fact a system by which, and
through which, our city's credit will be, as it
once was, equal to any, surpassed by none.

Once more, I repeat, all this can and should
be done, and for one looking to this desired
end, I trust the resolution will be adopted.

A NEST OF VERITABLE BLACKLEGS ROUTED. been the rendezvous of a number of colored gamblers who plied their calling in the open air unmindful of the powers that be. This unawful gathering has been a nuisance to the neighborhood, and yesterday a raid was made upon the gang by a portion of the detective and police forces, which resulted in the capture of eleven of the gay gamboliers. They were coolly shuffling their cards, not expect ing any intrusion,

"When the police came down like the wolf on the fold,

Their cohorts all gleaming with blue and with gold.

Every avenue had been guarded, and when the alarm was given the besieged saw that escape was cut off, that clubs were trumps, and calmly laid down their pictures. Some of the more adventurous spirits took to the marsh, but found that mode of exit impracticable, and were also numbered among the captured. They were marched to the guardhouse, and assigned quarters which were more close than comfort able. The news of the capture was no soon r noised abroad than it created great consterna tion among the colored fraternity. There was a gathering of the clans around the portals of the gnardhouse, and a weeping and wailing among many of the colored Rachels who refus ed to be comforted. The gang which was broken up was composed of young colored men between twenty and thirty years of age, who have long been under the surveillance of the police. They are charged with gambling and vagrancy.
