ABRIVAL OF THE BRITISH STEAMSHIP CA-MILLA-THE SECOND SHIP OF THE LIVERPOOL LINE. The British steamship Camilla, Captain Peace, arrived here yesterday afternoon from New York, consigned to Messrs. R. Mure & Co., who will imme diatoly place her on the barth for Liverpool. The Camilla is a first-class iron propeller ship, constructed by Messrs. Palmer Brothers at Howden, on the Type, in 1866, and has been generally engaged in the trade between the Mediterranean Sea and British ports. She is 795 tons, about 215 feet in length, 28

feet beam, and 17 feet hold. Her capacity for cotton stowage will probably amount to about 2000 bales. 
