HORRIBLE BUTCHERY.

A Negro Nearly Chopped to Pieces with an Axe or a Hoe-Inquest.

About half-past three o'clock yesterday afternoon the body of a negro man was observed floating in the Ashley River, near the bathing bouse, at the South Battery. It was bauled EACH WEEK, ACCORDING TO THE PROVIS- upon the shore and the Coroner notified. He mmoned a jury at once, and held an inquest. There was no testimony, and although the body was examined by a number of persons, no one recognized it. After viewing the body and waiting some time to ascertain whether which is about twice as large as that of any the body could be recognized, or any testimony could be produced, to throw some light upon the transaction, the jury rendered a verdict, in substance, that the deceased had been mur-For persons who want situations or servants; dered by a party or parties to the jury unwho want houses or apartments, or have them known. The general condition of the body rendered its speedy burial necessary, and the Coroner, although desiring to keep it, with the hope that it might be identified, felt com-

pelled to order its burial. The body, when found, had been in the water about twenty-four hours. There was nothing upon it but an old tattered coat. It was horribly mangled. The body had floated down the Ashley River with the ebb tide. It is believed that the murder was com mitted in the upper portion of the city, and then thrown into the river. Who the deceased was, who was the murderer, and where the murder was committed, are yet to be ascertained, and there seems to be no clue that will lead to the obtaining of the desired information. The deceased was apparently about thirty years of age.

FREIGHTING SHIPS-A NEW BARK .- The early arrival of cotton is unusually large. The supply at this port has caused quite a demand for freight room, and vessels now due are anxiously looked for. On Friday last the new bark Annie Torrey, Captain Libby, arrived here from Richmond, Me., with a cargo of hay consigned to Messrs. W. Roach & Co. She came in good time, and was fortunate enough to seoure through her consignee a considerable portion of her cargo for Liverpool at 9-16d. on upland cotton. The Annie Torrey is just off the stocks at Richmond, Me., and has been constructed with great care by her builders, Messrs. Thurlow & Elwell, who have furnished her with all the latest improvements. Parson Cain Warns the Peculating City Officials of the Wrath to Come-Let

It is really surprising on how many points Parson Cain and TRE NEWS think alike, notwithstanding "the occasional political extravagances into which the black shepherd is berayed. In Saturday's issue of the Missionary Record he polishes off our municipal vultures in very handsome style. After depicting in glowing terms the public confidence and prosperity that would result from an administration of city affairs by honest, capable and respectable men, he goes on to say: But when a venal class usurp the functions

And yet rumor alarms us of transactions per-petrated by high officials detrimental to our interests. We are led to these reflections by petrated by high officials detrimental to our interests. We are led to these reflections by the facts in our possession of certain "peculations" and needless expenditures of a certain "ctique" in our City Council, who are said to be feasting off the people's money. We warn those faithless public servants that there are honest men in the Republican party who will not suffer them to bring the party into disgrace without lifting their voice against their needless expenditure of the people's hard earnings. While they pay the poor laboring man a mere pittance for his hard day's work, they drink their "sherry" and champague, and drive fast horses. Sirs, there are a host of honest men who are observing your course. That "ring' will not remain in power forever. No, the indignant people will rise up in their No, the indignant people will rise up in their might and crush them to powder. Beware! "the Strocco cometh," and terrible are the judgments of the people. They will not always be led to slaughter by the bloody-handed batchers.

UNSOUND FISH .- A negro named Charles Cormick was arraigned before the Mayor Saturday, to answer to the charge of attempting to sell unsound fish in the Market, and for abusing the Clerk of the Market when he told him he should not sell them. Charles was of the opinion that freedom gave him the privilege of talking as much as he pleased, and so asserted. The Mayor discharged him with a reprimand.

ACTIVA FREIGHTS.—Business in this city has opened with greater activity, and has assumed more decidedly the character of a prosperous healthy trade than at any time since the war. The fairly paying prices which the South now enjoys for her staples will, ere long, restore her to more than her former comfort and wealth. Among other branches of commerce which are steadily improving, is the intercourse along the coast, which is now large and gaining, and its present importance was indicated on Saturday last when five steamships left this city for the leading Northern centres. These vessels were the Manhattan, for New York, with 1438 bales cotton; Minnetonka, for New York, with 1168 bales; General Sedgwick, for New York, with 451 bales; J. W. Everman, for Philadelphia, with 566 bales; and Sea Gull, for Baltimore, with 397 bales; forming a grand total of 4020 bales cotton. Extra steamships have been placed on some of the lines, and are securing heavy cargoes.

A NEGRO CONSTABLE SHOT .- Abou' dark on Thursday evening, Sam Spencer, one of the negro selectmen of Hamburg, and Gus Robinson, the mulatto constable who figures around Prince Rivers' Congo Court, with their artillery buckled around them, took an official stroll down the South Carolina Bailroad as far as the Dead Fall. Their object, we learn, was to procure the arrest of a subject, to be dealt with. we presume, according to the most approved misunderstanding of the law for which Rivers whose names we have not ascertained, one of two shots at the white men, but must have fired wide of the mark, as himself and associate soon returned to Hamburg without effecting any arrest. No arrests have yet been made, but the "loil" were in a ferment Friday morning, boiling up the occurrence as a Ku-Klux outrage for publication. It may be very safely assumed that somebody will be arrested-whether the right one or not being a matter of small concern to the Radical sense of justice which controls the new regime.

From an inspection of the plans, including the style of decorations, &c., we are glad to be able to express the opinion that our new opera house will be by far the cosies handsomest, and most complete temple of the drama that the South can boast. Combining the best features of Booth's and the Fifth Avenue theatres in New York, it will enjoy some decided advantages over either of them. The pitch of the pit and three galleries will be such as to offer a full and casy view of everything behind the footlights from every portion of the house; and the noble proportions of the stage will afford ample scope for the producduction of the grandest and most elaborate scenic effects. The prospenium boxes, four in number, will be richly ornamented, and the frescoes and general adornments will be a faithful reproduction of those so generally admired in Brougham's beautiful little Fifth Avenue theatre. Altogether, the operahous bids fair to be an attraction added to our city,
