-Copies of certain Belgian journals intended for circulation in France have been intercepted and seized bethe French authorities. This act coming after the declaration that foreign journals were to be free from censorship excites surprise, and the Radical journals accuse the government of inconsistency and bad faith.

-The following report from Havana was reecived in New York City Thursday night by the Spanish Consul: Two insurgent chiefs, Coca and Carballas, have issued a proclamation endorsing the cause of the Spaniards. The official Gazette of Hayana will shortly publish the announcement that the collection of taxes will be discontinued.

-Ten thousand men have struck at a town in politician, is the principal factory owner. This is the latest and most oferwhelming wave of that labor agitation which has been a portentous sign of the hour in France. A few more such strikes as have lately happened will hasten the more general strike for revolution.

-The French ministry has declared its intention of proposing that all offences of the press be tried before a jury, but as this proposition has not yet become a law, Rochefort, whose trial soon takes place, will not have the privilege of pury. -A few days since it was positively and officially announced that Raspail, one of the leading members of the Radical party in the Corps Legis latif, was dead. -The organization of the committee on Eastern rites and apostolic missions of the (Ecumenical Council is now complete. -The Southern people are watching with intense interest the cotton tax case pending before the Supreme Court of the United States in Memphis. They argue that if cotton can be thus taxed, while the products of other States are not subject to taxation, the cotton States are virtually outside the pale of constitutional equality, and their products in constant peril of confiscation, involving rain to the producer. The decision will have an important bearing on the next planting.

-General Butler failed twice in the House on Friday to get the floor to reply to Mr. Dawes' speech of Tuesday, and to defend the administration from the charges of extravagance which the latter made so glaringly. Mr. Dawes, notwithstanding the abuse heaped upon him by some of his own party, intends to stand by his record, and will make a speech in defence of his first one. He has received letters from Horace Greelev, the editors of the New York Post, Boston Traveller, and other Republican journals, warmly commending his expose of extravagance.

-The train tendered by the Eastern Railroad to convey Mr. Peabody's remains from Portland to the place of burial has been completed in the workshops of the company.
