INTERESTING TO FIREMEN.-There is now to reach that city via the South Carolina Railroad on exhibition in Savannah a new invention for the extinguishment of fires, called the "Chemical Fire Engine," which will be given a public trial to test its adaptability to the work which it professes to accomplish. The apparatus of the engine may be described as extremely simple in construction, consisting of a small tank of water, carts are employed daily in hauling it, the a force pump, and an air chamber, which also contains a fire extinguishing compound. The water passing through the air chamber becomes impregnated with the chemical compound but the gas is not produced until the mixture reaches the fire, when it extinguishes it. > NOT HUNG,-LIEUTENANT-GOVERNOR CORBIN GRANTS THE MURDERER NIXON A RESPITE.-Yeshours of 10 and 4 o'clock terday, between the was the time appointed for the hanging of Friday Nixon, colored, who was tried and convloted at the last November term of court for the murder of Dick Richards, colored, on the night of September 24, on the Ashley River. As the Governor, who had before granted the condemned a respite for thirty days, was absent from the State, it was generally supposed that the execution would certainly take place. Long before the hour of 10 o'clock, a large crowd of colored people assem oled in the vic nity of the Jail, and waited patiently for the hour of execution, each one doubtless thinking that in some way or other he would secure ingress to the Jail-yard, despite the strict orders that none but those who were compelled to

att nd the execution should be admitted. About 10 o'clock, a report that there was a prospect of the prisoner being respited, caused coniderable comment and some little disappoint ment. The report proved to be true. Early in the morning Major D. T. Corbin, who is Lieutenant-Governor of the State and acting Governor, was importuned by the friends of the condemned to respite him until Governor Scott returned to his duties, when they would be able to present such statements as would cause a commutation of the prisoner's sentence to imprisonment for life in the penitentiary. The acting Governor granted a respite for twenty-eight days. The respite recites that as "it has been represented that the respite of the execution of the sentence of death upon Friday Nixon for thirty days, on the 23d day of February, by Governor Scott, was had for the express purpose of giving opportunity of presenting considerations for a mitigation of said sentence, and that said respite of thirty days having expired without the opportunity being fully enjoyed, by reason of the absence of the Governor from the State, therefore the execution is respited for twenty-eight days, and until Friday, the

22d of April next." When the news of the respite was communic ted to the condemned he evinced no emotion whatever, and simply remarked that he was prepared to die, was ready to go whenever he was called upon, but was thankful to those who exerted themselves to obtain the respite. Remarks of Colonel Richard Lathers, at the Annual Dinner of the Hibernian Society, on St. Patrick's Day.

The numerous friends of Colonel Lathers will be gratified to read a full report of the remarks delivered by him at the dinner of the Hibernian Society, on the 17th instant. Colonel

Lathers said:

Mr. President and Gentlemen of the Hibernian Society—I find myself embarrassed for want of suitable words to convey my gratitude for your kind and hearty reception of the flattering sentiments expressed in the toast of my iriend, Colonel Bruns. I have all of an Irishman's qualities but his cloquence, and the exhibition of that accomplishment needs no further illustration tonight to establish the claim of a Charleston festivity to a high rank in that art which Burke, Curran and Emmett so eminently fix as a natural Irish accomplishment. But in common with the instincts of our race, to even the third and fourth generation, affection, sympathy and kindness are generation, affection, sympathy and kindness are qualities which cannot be eradicated from an Irishman's heart towards our old homes and th friends of our childhood; and while full of gratitude to my Northern friends for the many sub stantial evidences of their kindness and liberality which I have received during a residence of over twenty years in that glorious City of New York, during which time I have been fostered, encouraged and sustained by the liberality of that mer-cantile element which, true to the instincts of cantile element which, true to the installed of commerce, rises above the prejudices of sectional, religious or political differences, I return to my early home in Carolina with inexpressible satisfaction, and I am ready to assume my share of her burthens, and to aid, as far as my feeble of her burnens, and to aid, as it as by restoring her powers and means will justify, in restoring her and her citizens to that equality as a State, and to those rights as individuals, which are guaran-teed by the great charter which constitutes us a nation of freemen under a federal republic of
