

-A design for a new two-cent revenue stamp has been approved by the commissioner, by the operation of which persons living at remote points, say from New York, may have their checks, drafts, &c., printed at home, at their local printing offices, and the trouble sayed of fixing adhesive stamps.

-The Cuban war has had the effect of driving a large number of business men to Key West, from various parts of the Island, and the manufacture of cigars there is on the increase. The customs receipts this year at that port will .exceed \$60,000, while for the previous year they were only \$6000.

-The accumulated evidence from all parts of Mexico reveals the condition of that country as in every sense deplorable. Financially bankrupt, socially demoralized, and politically disrupted, there is protection neither for property nor persons.
