AMUSEMENTS.

The Academy of Music Last Night. The Charleston public may daily with omedy and coquet with burlesque, but they have an ingraiged liking for the legitimate drama which, in this city, never fails to draw a numerous and somewhat critical audience. It is not surprising, then, that the Academy of Music last night was filled from pit to dome. Mr. Edwin Forrest was looked upon as one of the veterans of the stage, to whom the playgoers of this year of grace might point as an evidence of what dramatic art was in those palmy days when a galaxy of great actors tood the American and Trans atlantic boards. Twenty years ago he had reached the zenith of his fame. It was hardly expected that Charleston would see him again; still less was it thought probable that he would convince the public, by ocular demonstration, that his great powers were undiminished, and that mature age had subdued, without enfeebling, the fire of his youth, while it left untouched the barmonious utterances which give to all his readings an enduring charm.

The progress of Mr. Forrest through the South nas been a triumph. Richmond, Wilmington and Angusta have vied in showing their appreciation of his artistic genius, and none have given him a warmer welcome than he received in Charleston last night. When he appeared on the stage he was heartily applauded, and throughout the play he was followed with an earnest attention which culminated in the fourth act, when the spiendid declamation of the great tragedian aroused all the enthusiasm which, in a Charleston audience, usually lies dormant. For some moments the progress of the play was stopped, and when the act was ended, Mr. Forrest was called before the curtain and again applauded to the echo. In the first three ac's Mr. Forrest's acting was subdued, and even gentle, his bitter jesting with Father Joseph only heightening the tenderness of his colloquie with the charming Julia. But in the fourth and fifth acts, rising to the level of the dramatic situation and controlling it, he had not only France, but his audience "at his feet." Mr. Forrest has still the cowerful form, the sonorous voice, the grace of gesture and the flery passion which were the charm of his glorious prime. The robustness of method which jarred on ears polite is now toned lown, but he has lost nothing of the qualities which constituted him one of the first among the

TERRIFIC BOILER EXPLOSION .- One of the boilers at the Charleston Steam Saw Mid, more generally known as Steinmeyer's Mill, exp'oded yesterday morning, at about half-past 10 o'clock, completely demolishing a two-story building and causing other damage. One piece of the botter about five feet long, was thrown a distance of about one hundred and difty yards, and partially buried in a lot on the south side of Beaufain street. The other end, about twenty feet long was thrown about forty feet, tearing its way through the heavy brickwork surrounding it, cutting away the massive beams supporting a large water tank, destroying a brick chimney seven feet square at its base and eighty feet high, and throwing a large heater upon the engine which stood within the main building, damaging both considerably. The only persons injured were Nor ris Huggins, a colore I man, who was at work in the room over the frehouse, sharpening saws, who was very badly bruised and scalded, and one of the firemen, also a colored man, named Grant, who was slightly scalde l. There is no clue whatever to the cause of the accident. Mr. George E. Steinmeyer had tested the water in the boiler, not five minutes before the explosion occurred, and states that they were well supplied. The loss occasioned by the accident will probably reach \$3500.
