THE USURY BILL KILLED .- Our Columbia telegrams bring the welcome news, that the Senate, by an overwhelming majority, has given a quietus to the bill to re-establish the usury law. The first announcement of this gratifying result reached the city yesterday in the following dispatch from Lieutenant Governor Ransier to one or our leading merchants: "The usury bill has inst met with a deserved death in the Senate. The enacting clause has been stricken out by a vote of 20 to 2."




