-The Shoemakers' Co-operative Association a Vassalboro, Maine, the only organization of the kind in the State, has ceased work. It is found impossible to make sales odvantageonsly in competition with large capitalists in other places.

-Last week the sum of \$65,780 was contributed in New York towards finlaning the new Catho-lic changing in that day. Pattage Byrne gave \$6000, Engene Kelly \$5000, Wm. and J. O'Brien \$5000, Barney Williams \$1000, and various others imilar amounts.

-An "American innovation" has crept into the British House of Commons. The old tea-room has disappeared, and a handsome refreshment recess a bar has been opened where members and their friends may refresh themselves.

-Some time ago Jim Fisk "became infurlated with Lea Silly, the star at his theatre, and telegraphed as follows to a distinguished London banking-house, with which Jim occasionally did business. 'Send me Schneider, per next steamer, coute qui coute, (at any cost.') Imagine the indignation of these London banking princes at being requested to send a dansense to Jim Fisk. Their reply was brief and to the point: 'Not in our line. I Jim felt rather sheepish when he go that telegram."

-The New York Sun correspondent, after giv. ing the names of nine correspondents accompanying the San Domingo expedition, says: 90 the above named gentlemen, six to my certain knowledge will report in favor of annexation; they will state that the island is a paradise, that the Dominicans desire to be annexed, and some will go so far as to assert that the white man can labor, thrive and keep his health here. Of the others, I am inclined to think that before the return of the expedition two, or perhaps even three, will be converted to the annexation scheme."

-A Washington letter of Saturday says: "For the first time since the institution was organized. Remiblican Congressmen from the West came out with their voice and votes in the House yesterday, and denounced the greedy clamer of the Freedmen's Rorran for mor. noney. One member commented 'on the reluctance with which the officers of that institution let up their hold on the public crib,' and spoke pretty forcibly on the way the bounty appropriations of Congress for colored soldiers were made away with. The result was, that the House reduced the appropriations of this bureau just one hundred thousand -The abolition of the purchase system in the

British army is essentially of a Democratic and radical character. It has been introduced by the Gladstone Ministry, in obedience to the clamor for army reform, and to neutralize the policy which the Tory party are expected to pursue Under this purchase system the commission of lieutenant-colonelis estimated as worth \$52,560: and the lower grades have different prices, regulated by custom. As a general rule, no commission can be obtained in the British army without the purchasing it from the officer who retires, and at the same time paying a considerable sum to the regiment. This system has led to grave seand given wealth undue predominance over ment. The army has been justly called a "processe for the younger sons!" of the nobility; and offers no adequate incentives to young officers of moderate means. Lord Russell recently proposed the abolition of the purchase system, and has been supported in his views by other eminent public men. It is estimated that the cost of compensating officers for their commissions on

the adoption of the new project will be \$55,000,000. -The new bayonet election bill, which has now named both Houses of Congress, called the enforcement act, and which is designed to exceed in effectiveness as a piece of election machinery that of the last session, will, it is to be presumed become law by the favor of the President. We have heretofore given a pretty full exhibit of its astonishing provisions, under which penalties of fine and imprisonment are imposed regarding the registration of voters, which is virtually to be taken possession of by the Federal officials, and also the conduct of the elections-the opera tion of the act to be no longer imited to cirles and towns of 20,000 inhabitants, if two citizens ask for its application in places of lesser note. The Greenville Ring know full well that they cannot carry on their speculation without money. They have deservedly failed to expected, therefore, that they should fight desperately to secure the passage of their dollars of endorsed bonds, which bonds are, at once, convertible into bonds of the

But the Senate are pondering the whole vexed question. They know that the Greenville Bill proposes, in plain truth, to give the Greenville Ring State bonds to the amount of two million dollars. They know that it makes necessary an additional State tax of \$120,000 a year. They know that it will depress still further the State credit. They know that it will discourage the whole people, and interfere with the collection of taxes, while it encourages a dangerous spirit of turbulent disaffection. They know, moreover, that Governor Scott will veto the bill, if it passes the Senate, and that the Executive will appeal to the courts to prevent the Ring from reaping the reward of

These considerations have made the Senate pause. We now entreat them-in the name of honesty, decency and common justice, in the name of the people whom they are elected to represent-to meet this question fairly and fully, and to prove, by their defeat of the Greenville cheat, that, whatever the corrupt ignorance of the lower House, the Senate do still regard the interest and the honor of the State.

The English journals are actively discussing the appointment of the High Commission for the adjustment of the differences between Great Britain and the United States. There is an evident desire to be on friendly terms with America; but a doubt lurks in the minds of many sagacious observers whether this country has not deliberately adopted a policy which makes a neighborly understanding irapossible. Mr. Disraeli's speech, printed in our issue of yesterday, is the outcropping of this misgiving, and an idea is spreading abroad that a settlement consistant with the honor of England may be put out of the question by the windy politicians who lead the American masses. The Saturday Review, which has no love for Mr. Disraeli, and has stoutly supported the English policy of neutrality during the Franco-German war, is disposed to side with the leader of the opposition in his rebuke of the 'rowdy rhetoric" of Congress, and expresses very plainly the fear that any concessions made to America will only provoke fresh demands. As a faithful declaration of the sen-

timents of a large body of thoughtful Englishmen, we reprint the greater part of the Saturday Review article upon the relations of America with Great Britain: "As the proposal that the Alabama claims

should be referred to the commission was made by the President, the English Government has not committed the error of renewing the controversy which was interrupted by the relection of Mr. Reverdy Johnson's treaty; but it would have been difficult to select a less auspicious time for the establishment of that be, in a measure, independent of the commerneighborly understanding which Mr. Gladstone hopes against hope to cherish and maintain. A prime minister is perhaps not to be blamed for persisting to the last in the use of conventional expressions of good feeling; but no man really believes that the judgment and good sense of the mass of the American nation will discountenance, neutralize and dishearter whatever inconvenient effects rash speakers may produce '. The spiteful speaking is prompt ed, not by rudeness, but by sycophancy to the mass of the American nation, which last year elected to represent its opinions the hundred and seventy-two members, who lately concurred with their chosen leader in offering a wanton and ill-bred insult to the English Government and nation. It is for the purpose of securing the votes of the same mass that General Grant sends a message to Congress as hostile and as threatening to England as one of the proclamations in which Napoleon I was in the habit of preparing his subjects and armles for some new war on his neighbors. Mr. Disraeli, though he has in his time been not less addicted than his rival to the use of conventional phraseology, spoke, on Thursday night, in a tone of manly plainness, which is perhaps more likely to produce an impression on American opinion than the exaggerated deference which has been so long and so consistently misunderstood. It is true that, as Mr. Disraeli said, the Sumners and the Butlers abuse England because they believe they can

do it with impunity. No English politician

has a better right than Mr. Disraeli to use di-

geous vote of the House of Representatives. "If it was desirable to appoint a commission, no objection can be taken to the selection of the members who are to compose it. Mr. Gladstone and Lord Granville deserve credit for their appointments of two Canadians on a commission of four members. The doubtful policy of eager attempts to conciliate American hostility would become utterly unjustifiable if it involved any slight to the Dominion of Canada. General Butler and General Grant have committed an obvious blunder in founding one of their pretexts for quarrel with England on a Canadian grievance; and it would be a culpable act of weakness to relieve them from the consequences of their error by diverting the indignation of Canada from America to England. The allegiance of the colonists would be dangerously shaken if they had reason to suspect that their interests were about to be bartered for the relaxation of American demands in the Alabama matter. As the negolistion on the fisheries has already comnenced, there is some reason to hope that the Canadians will be contented with the arrangenent which may be concluded by the commis-

"The choice of American commissioners oncerns the government of the United States, and the names which were mentioned by Mr. Gladstone are not specially objectionable to England. The main objection to the whole cheme is the want of an arbitrator who may decide questions on which the commissioners are divided. A joint commission, though it may be well qualified to settle matters of detall, must necessarily come to a standstill when the main issues between the two countries arise. Mr. Gladstone declares that the instructions furnished to Lord De Grey and his collecgues will prove that the honor of England has been carefully guarded; but Mr. Gladstone sometimes holds peculiar views of national honor, and it is not yet certain that his government may not have yielded the only points which were really in dispute. Since the time of Lord Russell, concession after concession has been made to American exigency. with the uniform result of provoking more unreasonable and more offensive demands. It will be singularly unfortunate if it should appear that the president of the council has been sent out to America, like the citizens of Calais when the town was surrendered to Edward III, with a rope round his neck, in token of submission and of appeal for mercy. A capit ulation immediately following the President's message and the vote of the House of Reprecentatives would not even purchase lasting eace at the expense of national humiliation. The fisheries grievance and the St. Lawrence have been recently started, and the politicians of the United States have an inexhaustible store of similar complaints in reserve. The whole history of diplomatic transactions between England and America consists of aggressions and threats on the part of the United States, too often provoked by excessive English pliability. 'If overbearing rudeness proves to be once more successful, it may be predicted that the next demand will extend to the annexation of the English dominions in North Amer

A Navy Yard at Port Royal.

In view of the fact that Brooklyn wants to get rid of her navy yard, and that Congress is discussing the duestion of removing it to some more suitable point, the Columbia Union urges the claims and advantages of Port Royal as a navy yard site. It says:

"The South has nearly half the Atlantic and Gulf coast line, and has not a single first-class navy yard. Port Royal harbor is the best on the Atlantic coast, and we have no doubt that English Feeling Towards the United | States upon which to construct a first-class navy and ship yard. Such an enterprise would build up South Carolina materially, and would be the means of laying the foundation for a commercial city which would rival any city on the Atlantic coast."

"With the Blue Ridge and Port Royal Ral!road open to the West, and a line of European steamships established, both from Charleston and Port Royal, South Carolina would march on in prosperity, until she rivalled the most

prosperons States in the Union." "There are commercial advantages possessed by us that are not possesse i by any of the States of the North. We are nearer, by many hundreds of miles, to the rich and productive Island of Cuba and the other West India group, the Bahamas lie just off our coast, and the South American trade is three days nearer our markets than it is to New York. Our climate is more attractive, and business mea and capitalists would flock here by the thousands, it they could but see the way to do so.

"We ask our delegation in Congress, both in the Senate and in the House, to press this matter of the excellency of Port Royal harbor home upon the attention of their respective bodies, and not to rest until favorable action is taken. Congress owes it to the South to do everything in its power to aid in building up and developing the interests of this section. The country here is poor, financially, and not so well able to help itself as the rich and prosperous North and West; and while millions upon millions of the public funds have been lavishly expended upon those sections, to foster and aid enterprises that were more of a private than a public nature, not one dollar has been given to aid an enterprise of a public nature throughout the entire South. With a Southern Pacific Bailroad, and a connecting link with Charleston and Port Royal, we should cial metropolis of the North, and could command a trade the importance of which it is impossible to estimate."
