Reception by the Chamber of Com merce-Excursion in the Bay and Visit to Fort Sumter-A Testimonial from Charleston to Wilmington-The Future Programme.

The Charleston committee of reception wait ed on their Delaware visitors at an early hour Saturday morning at the Charleston Hetel, and escorted them down Meeting and Broad streets to the Chamber of Commerce building at the corner of East Bay, where a reception awaited them from the representatives of the commercial interests of the city. The visitors were first taken to the large reading room of the Chamber, where they were cordially welcomed to the city by the president, Captain Samuel Y. Tupper, on behalf of the Chamber of Commerce, and as a veteran fireman who was still alive to the interests of the Charleston Fire Department, although he had passed his time of active participation in its duties. Mr. J. Frank Hazell, of the visiting company, briefly replied, repeating the assurance of their profound appreciation of the flattering reception that had been accorded them by the firemen, the citizens and the commercial repre sentatives of Charleston, and Capt. Tupper then introduced the Hon. George A. Trenholm, who expressed the gratification of the Chamber at the opportune and auspicious visit of their Delaware friends to their city, which was just emerging from a period of trial and affliction to enter upon a career of renewed and increased prosperity The band then struck up the Star Spangled Ban ner, and the rather novel sensation of hearing s national air in the rooms of the Charleston Chamber of Commerce was experienced, until the melody changed to the more familiar Dixie, succeeded by the Bonnie Blue Flag. The party next proceeded to the lunch-room, where a slight collation and a claret punch was disposed of, after which the visitors and the committee, preceeded by McClurg's band, marched down East Bay to South Atlantic wharf, where the steamer Emilie, of the Georgetown line, was in waiting

The Excursion Down the Bay. Here the party embarked and the steamer got ander way at about eleven o'clock. The passage down the harbor was very pleasant, but was de void of incident until Fort Sumter was reached, when a landing was made and the party entered the gloomy ruin and began a rambling search for its objects of interest and its grim souvenirs of "the times that tried men's souls." Lanterns were brought and the circuit of the subterranean bomb proofs made in single file. Scraps of metal and splinters from a venerable looking spar, that was fondly believed to be the genuine flagstaff defended by Major Anderson, were collected by the Wilmingtonians, as souvenirs of their visit and the ruined walls were scaled and the notes of Dixie and the Star Spangled Banner peacefully blended from the parapet, until at the beating of the long roll the party reassembled for The Presentation,

which was the principal event of the morning. The Delaware Company and the Charleston are men were drawn up in opposite lines in the centre of the desolate parade ground, and President Augustine T. Smythe stepped forward to present the testimonial. He congratulated the visitors upon their happy and peaceful visit to the scene of so much strife and suffering, and congratnlated the Charleston representatives upon the happy auspices under which the visit had taken place. When they had first heard that a company of firemen from Delaware desired to visit this city, it was cheering news. They were just emerg ing from a season of trial and suffering—the tide had turned and fortune seemed again to smile upon the dear old City by the Sea. The fever had left them, their streets were again filled with people, the commerce of the world was again crowding their wharves, and they had just suco eded to deposing a corrupt and shameless government which had been disgracing their city and eating out its very vitals. Then came the visit of thei Delaware friends-a fitting omen of peace and od will, and a happy portent of the career of prosperity on which the city seemed about to enter. In recognition of this event, and in imitation of the Roman habit, where the host, in taking eave of a visitor, pressed upon him some small present as a souvenir of the occasion, and a pledge of future hospitality, he begged to present to the Washington Engine Company, of Wilmington, Delaware, the testimonial that had been prepared by the steam fire engine and hook and ladder companies of Charleston, as a slight token of fraternity and esteem, and a symbol and earnest of past and future hospitality.

The Testimonial was then handed to Chief Marshal Quinn, of the Washington Company. It consists of a massive silves pitcher and two handsome goblets, the main piece being inscribed as follows:

Washington Steam Fire Engine Company, Steam Fire Engine and Truck Companies Charleston, S. C. Nov. 18, 1871.

Each of the goblets bears the following inscription:

Wilmington, Del., from Charleston, S. C., 1871.

The gift was received by Mr. Quinn, in a few words expressive of his appreciation of the courtesy and hospitality with which his company had been received. They had not been wholly unpre pared for such a reception, for they still cherished the recollection of a visit to Richmond in 1865, at a time of great desolation and discress in that city, where they had seen something of the proverbial, never-changing Southern hospitality.
They had known, therefore, that a generous recertion awaited them in Charleston, and they had not been disappointed. Their expectations had been more than realized, and they would go back to their friends in Delaware and tell them to do il that lay in their power to selle the calumni ators and ameliorate the cor dition of the noble, generous and chivalrous community of Charleston. He was unable, however, to give proper expression to his feelings on the (ccasion, and begged to present Mr. L Frank Hazell, of Delaware, who would more fittingly respond for the

Mr. Hazell said that even without the beautiful and costly souvenir they had just received, they would have carried back with them such recollec tions of their visit as would have been "apples o gold in pictures of silver." Every tocident of their visit had been one of pleasure, and at that moment standing as h did in the presence of the famous relics of the recent strife, he felt that there was no incident in his life more replete with interest or more deeply impressive. There was a fortress whose fame was as wide as the world, whose every stone was typical of a death, and every grain of mortar represented a drop of blood, and there were some of its defenders and some of those to whose arms it had at last surrendered. No nobler or more gallant garrison ever held a crumbling fortress till all hope was gone, and their actions speak in tones

This was presented to the Vigilants by Marshal Quinn on behalf of the Wil nington Company, and responded to by President Mowry, of the Vigilants.

The Wilmington Company then marched to the engine-house of the Æ:na Company, where quite generous entertainment awaited them. First, they were presented with a beautifully engrossed estimonial in an elegant frame, the presentation being made by Major E. Willis, on behalf of the Ætna Company and responded to by Marshal Quinn. Next, a handsome basket of japonicas was presented by Captain William Aiken Kelly on behalf of the sisters, wives and sweethearts of the .3tna Company to the visitors, to be delivered on their return to Wilmington to the ladies of their company, and received by Mr. J. There had been cities that had been utterly destroyed by fire. Sodom and Gomorrah had been swept from the plain by the wrath o God, and Babylon had been burned as related in the text, but he did not believe that in the providence of God the fiames could have a permanent potency over any city which was the home of Christian civilization and the seat of civic virtue. It was, however, in its spiritual effects that the compensations of a devastating fire were most that in a time of great distress to the people of Israel the prophet Elisha had gone to a cavern in a rock to seek a sign from God, and here he had been astonished by a series of most wonderful phenomena. First there was a tempest of wind and rain, but God was not in the storm; then came an earthquake that rent the cliffs asunder, but God was not in the cliffs; then streams of fire came pouring from the mountain side, but God was not in the firme; but, at last, when the fire was quenched, and the turbulent elements were hushed, there came "a still, smal voice," and Elisha knew that he had received the revelation of the Most High. In this case the Almighty did not clothe himself with the flame ear to his servant in a form of terror, but he used the fire as a herald to announce his approach, and to command attention to the still, small voice.
