interesting report: FOURTH ANNUAL REPORT OF THE HOME.

The board of control of the "Home for Mothers, Widows and Danghters of Confederate Soldiers," in presenting the usual annual statement of the condition of the institution, respectfully inform the association, that, owing to the change of the annual meeting from November to January—in order to con-form it to that of the Gentlemen's Auxiliary association-their report covers the transac

tions of fourteen months. During that period there have been resident in the institution one hundred and two dent in the institution one flundred and two persons. Of this number, one, a very aged widow lady, has died. There are now in the Home one hundred and one persons, being an increase of twenty-four over the number at the date of the last report.

The expenses of the institution for the period mentioned have been \$6255 56. Of this amount \$1733 70 were paid for the rent of the build-

ing; \$25 36 for repairs; \$415 40 for furniture; \$2600 for household expenses, including coup for inmates, and food, fuel, lights, service and washing for forty-live pupils; \$270 for salary of matron and assistant; \$840 for salary of the coupling and salary of the teachers; \$50 20 for printing and stationery; \$50 for hire of plano; \$18 75 for prizes for pu-pils, and \$4 65 for incidental expenses. It was selimated at the beginning of the year that \$6000 would be necessary for the maintenance of the institution for twelve months. The board take pleasure in pointing out the fact that the expenditure for four:een months has

that the expenditure for four een months has but a little exceeded the estimate made for twelve. All the expenses of the year have been fully met.

The board again gratefully acknowledge in debtedness to the Gentlemen's Auxiliary Association for generous liberality and efficient co-operation. This organization has naid for the support of the insutution, since the last report, \$1855. There have been received also from pay, pupils for board \$1455 72, and from tuition of day scholars \$100; from special donation to the school \$30; from rent of rooms \$210, and from annual subscriptions of members of the Ladles' Association \$240.

The health of the institution has been remarkable. With the exception of the lastance of the aged widow whose decease has been of the aged whow whose declare has been but two cases of serious sickness, and one of these occurred during the prevalence of the pestilence which invaded our city last summer. The continued liberality of the Washington Light Inantry Charitable Association has given gratu l'ous medical attention and medicine to the Hous medical attention and medicine to the Home during the past year, and we make no less grateful mention of this kinddess, although so little required to avail ourselves of it. For the present year Dr. Francis L. Parker, the surgeon of that association, who has been the faithful physician of the Home from the be-

ginning, has generously volunteered his services. The board also again acknowledges its obligations to Dr. J. R. Solomons. obligations to Dr. J. R. Solomons.

In the last report the fact was announced that a school had been organized in the institution. This seemed necessary, in order effectually to carry out its purposes. It was important that the pupils of the Home should be under the immediate supervision of the board, who were responsible for their welfure. who were responsible for their welfare; slight ind spositions would often prevent regular attendance upon schools widely separated throughout the city, and such attendance in all kinds of with welfare, was the frequent cause of sickness. The probability seemed great, moreover, at the date of the last report, that the public schools would close before the end of the year. The eyent has justified the experiment. The school at the Home was in efficient operation during the year. The progress and deportment of the year. These were eminently satisfied on the satisfied of the close of the term. factory.

During the year so many applications have

been received for admission to the Home, that the board have felt warranted and compelled been received for admission to the Home, that the board have felt warranted and compelled to extend its benefits still farther, and to receive as many as the building will accommodate. They have, therefore, begun the present year with fifty-five pupils, representing nearly every district of the State. But four of the entire number are from the city, and all of these are pay pupils. This large number of young ladies are now pursuing their studies in the Home school, under the care of the capable and approved teachers who have had charge of the school from the beginning, assisted in the primary department by those of the more advanced scholars. From the report of receipts given above, it will be noted that the pupils of the school are not all beneficiary. Where there is ability to pay, it is expected and required. Scholarships for the next year have been provided—one by Mrs. C. M. Manigault, of Brighton, England, and one each by several ladies and gentlemen of this city. From this source, and from relatives of pupils, and from day scholars, there have been receipts amounting to \$1560. In order that the advantages of the institution may be as widely distributed as possible, but one beneficiary can be received from one family.

The same branches of liberal study will be pursued this year as last. In addition, however, through the generosity of a lady of this city, who has been unceasing in her devotion to the interests of the Home, the valuable services of Madame Girard have been secured for advanced classes in French. The pupils of the school will continue to receive the kindly rendered instruction of Madame Plenge, and many young lailes of the city, in music.

The board acknowledge the unwearied liberality of the friends of the Home in donations of useful and valuable articles. The Charleston Courtier and DALLY News have laid us under new obligations for continual favors. Special mention is again due of generous contributions, throughout the whole year, of meat from Messrs. Thos. A. Johnson, James Dunning and Tim to extend its benefits still farther, and to re
