THE METROPOLITAN POLICE BILL.

Provisions of the Bill-A Total Cost of Seventy-Fve Thousand Dollars-An Electioneering Corps-The New Police Court-Taking Possession of the City Property-The Debate-Hurley's Hard Hits-Turning the Tables-The Bill the Special Order for Monday.

This latest device of the enemy proposes to put the city and county of Charleston into the hands of a sort of customhouse triumvirate, who are clothed with the most extraordinary powers, and who are to immediately possess themselves of a large share of the city's real estate, to summarily abolish the recorder of Charleston, all the trial justices in Charleston City; to supercede the Mayor and Aldermen in the exercise of at ast one important function of their offi and even to extend their operations at will to any section of the State. The treasurer is prohibited from paying the inter-est on any bonds until the report of this com-mittee be received, but he is carefully intructed to pay all the expenses of the com-
