London, with a population of 3,251,000, has 123,849 paupers, or about one pauper to every twenty-six of the inhabitants.

The fact that over six hundred personal applications, mostly by girls between fifteen and twenty, were made in one afternoon lately at the Grand Opera House, New York, to fill places, in the ballet of a new spectacular play, is noted as an evidence of a fearful lack of employment among the girls of that

-The Iron sea forts now in course of construction for the defence of the prominent naval stations of Great Britain will, with the foundations, cost five million dollars spiece. The iron shell of one of the forts for Spithead, near Portsmouth, has been shipped by rail for that harbor from the works of the Whitworths, in the iron districts. This shell or skeleton weighs twenty-four hundred tons, and is to be fitted up with fifteen-inch iron plates twentyalx feet in length. Each fort is to be seven hundred feet in circumference and two hundred and thirty feet high. They are to be armed with two tiers of guas, one tier of twentyfour 600 pounders and the other of twenty-five 400-ponnders. The guns, it is calculated; will plerce-twelve-inch armored ships at two thousand yards distance.

— The resignation of Colonel Forney, as col-lector of customs, at Philadelphia, was handed to President Grant on Saturday last. The letter of resignation has in it no word in praise or support of the administration or the acts of the Executive. Colonel Forney says he will devote his efforts to his newspaper "and to the energetic support of the principles of the great Republican party," He thanks General Grant for his kindness and consideration, but he don't say a word about supporting him for renomination. He reluctantly accepted, the office of collector because he apprehended it would seriously interfere with his business, and especially with his independence as a journalist. After ten months' experience he is entirely confirmed in this impression, all of which means that whilst he held office he was under obligations to maintain the administration and support Grant, and that he has, in the meantime, been forced to do violence to his better judgment, and that now he throws off the official shackles, and is free to criticise General Grant as a candidate for re-election to the office of President. It is a well-known fact that Forney is not a believer in the great political sagacity of Grant, and does not approve of his management of party affairs in some respects, and we may in due time expect to hear from Forney to that effect.

A letter from Berlin, Prussia, states that a spirit of speculation is taking possession of the staid people of that great capital of a million inhabitants somewhat similar to that which affected us toward the close of our recent civil war. Most of the necessaries of life have, within a few months, advanced there twenty-five to fifty per cent. Real estate, in speculative sections, has gone up one hundred per cent. within a year. Private manufacturing concerns are being turned into stock compasies with generous capitals, and at least six banks have recently been formed for the transaction of brokerage and commission business, in connection with deposit and discount. In one instance, the writer is assured, where the capital of the bank is two million thalers, one prominent member of the Bourse has been paid four i undred thousand thalers for his business name, and the same broker employed to manage, the concern at a salary of twenty thousand thalers and half the profits. Forty per cent. of the capital has been paid-up-probably no more will ever be paid-and although scarcely in operation, the stock of this bank is being bought at an advance of seventy-five per cent. above par. There is no inflation of the currency, but there are wonderfully high hopes of the future of the capital of the German Empire. That there is to be a large amount of disappointment and considerable financial disaster there can hardly be a doubt. The result in this country fell far short of prophecy, and so it will in

-A New York letter of Saturday says: The mose noteworthy sensation to-day was the indictment of Mayor Hall conjointly with Tweed and Sweeney, in the Court of General Sessions, of frauds against the city of one kind and another. After the indictments were read, Mayor Hall rose and said: "I appear to respond to the action of this court Twice before it have I been counsel for offic als charged with official misdemeanor. One was a judge of this very tribunal. The other was a former mayor. They were each absolved, as I expect to be. I am here to offer ball. I am here to waive all irregularities committed by the grand jury, and I believe them to have been many. Nor do I demur to the indictment, nor move to quash it. I plead to the general issue and ask that an early day be appointed for the trial. The Railroad Meeting Yesterday.

The adjourned meeting of the stockholders of the South Carolina Railroad, held yesterday, passed off quietly; the proceedings being marked by practical business sense as well as lively patriotism. No The evident desire was to do the best possible for the safe-keeping and the improvement of South Carolina, as represented by our main line of internal communication, without indulging in any petty jealousy of neighboring cities and States. A large field is open to the railroads of the South, and to the seaports whose commerce they sustain. There is ample room for all, and it is better by far that powerful corporations should work harmoniously together than that they should, by rash competition, exhaust their treasury and become an easy prey to the attacks of adversaries whom, in the fulness of their vigor, they could speedily over come. This is the spirit which prompted the resolution offered by Mr. Trenholm, and unanimously adopted by the meeting.

The proposed lease of the road was discussed by Mr. Louis D. DeSaussure, by Colonel Lathers and by Mr. Trepholm. They held it to be a duty and a commercial necessity to retain in South Carolina the direction of our chief railroad. They were ready, as already remarked, to unite with the railroad companies of Alabama and Georgia for the purpose of securing to Savannah and to Charleston the business which naturally belongs to those ports; but they are not willing, and the people cannot be willing, to lead even generous rivals into temptation by giving them the key to our coffers-by making them the arbiters of our destiny, and holding out to them the promise of surpassing prosperity at the price of our misfortune.

The representatives of the Ring made no attempt to reverse the decisive vote of Tuesday. They felt their weakness, and did not care to risk a second fall. But they have ing more actively than ever. All day yesterday they and their agents were buying up South Carolina Railroad stock. Said Mr. John H. James, "If you mean to be patriotic and own your own railroad, why don't you buy the four hundred shares now hawked about the streets;" which shares, we may add, were snapped up by Mr. John H. James as soon as the meeting adjourned. And we are compelled to repeat Mr. James's told, and the frequent change of scene, and question: If the people are resolved, as a matter of interest and a matter of patriotism, to retain the control of the South Carolina Railroad, why do they allow the Ring to add daily to the thousands of shares they already possess?

The fight is only begun. Unless the people take measures for absorbing immediately a large part of the stock of the company, the Ring will have a controlling interest within ninety days, and before Christmas will have the South Carolina Railroad as completely under their thumb as though it were a street railway in Savannah, or an opera-house in the city of which Mr. John H. James is Mayor.

-We print elsewhere the result of the election held at the meeting. The board of directors were re-elected by an almost nnanimous vote, General James Conner taking the place of the Hon. Charles M. Furman, who declined a re-election.

The Tax on Type.

The American Newspaper Reporter takes up the question of the tariff on printing type, and shows the exorbitant tax levied upon the printing offices for the benefit of the American type founders. In the following table is given the price of type in Toronto and in New York :

Size Toronto. New York Nonpareil, per pound.....620 Minion, per pound......50c Brevler, per pound......440 Bourgeois, per pound.....40c Long Primer, per pound...36c Small Pica, per pound....340

According to this table, the American printers pay for their body type an average of 63 cents a pound, while the Canadian printers pay an average of 44 cents a pound. The difference in price is fifty per cent.

The tariff on printing type produces only a nominal revenue. It is prohibitory, and serves no other purpose than to increase the expenses of the most important manufacturing interest in the country. The Reporter shows that the annual production of printing in the United States is \$75,000,000, employing over thirty thousand skilled mechanics, while the annual production of type founding is \$1,500,000, employing about twelve hundred mechanics. If we add to the production of printers the advertising income of the newspapers, the production will amount to over \$100,000,000

such reasons cannot apply, be substituted. I whole newspaper press of the country is fleeced in order that the few monoplists may grow rich.

Mr. Voorhees, of Indiana, has introduced a bill to place printing type and material on the free list, and every journalist in the land should second his efforts. The press make and unmake reputations; they nominate and elect Congressmen. Where would the memhers of the present Congress be if their party newspapers had opposed instead of supporting them? We shall see whether the press, so potent in advancing the interests of others, cannot do something for themselves. If we work one-half as hard to induce Congress to repeal the tariff on type as we do to elect ungrateful politicians to fat places, the bill of Mr. Voorhees will pass through both houses without a halt.

The Congressmen from South Carolina were not elected by THE NEWS, but, for the sake of their own organs, present and prospective, they should become zealous advecates of admitting type free of duty. When type costs 44 cents a pound instead of 63, it will be easier to establish Radical sheets for the enlightenment of benighted South Carolina. They can be started upon a smaller subscription, and, when they begin to run fast, will require less public pap and less private pecuniary assistance.

If Congressmen Wallace, Rainey, Elliott and Bowen, and Senators Sawyer and Robertson desire a re-election, or if they only desire to do justice to their constituents, they will immediately take up the case of type, and give the House and Senate no rest until they remove that tax upon brains and education known as the tariff on printing

What the South Requires.

The effects of reconstruction are very plain ly shown in Louisiana, the value of cotton lands having very greatly declined from that of three or four years ago. It is stated that this result has not been produced by the change in the system of labor, or by any diminution in the price of cotton, which is nigher than it was before the war. The plant 3 have used every effort to recover themselves, but the value of land has steadily deteriorated, notwithstanding that a larger outlay has been made in the improvement and repair of plantations and buildings. The cause of this gloomy state of things appears to be the impoverishment resulting from exorbitant taxation, which has reached a sum very nearly equal to one-third of the total exportation of Southern products. Of course such an impost bears with especial severity upon agriculture, which is, and always has been, the main-stay of the South. It is useless to expect any change for the better until the Southern people, without let or hindrance from the general government, apply them selves properly to the establishment of their political affairs upon a healthful, social and economic basis. That is the first thing to be attended to. After that will naturally come retrenchment, reduced taxation and suitable efforts for the development of production. The natural recources of the South are immense, and we cannot doubt that the Southern States, after all their woes, will sconer or later enjoy an era of uninterrupted prosperity. But before that period arrives, there must be firmly established such a reign of law and order, and economic principles o government as will invite the employment of captial and assure public confidence as to its security. Without good government there cannot be public coufidence; and without pub lic confidence there cannut be any valuab permanent development of productiveness.
