Court-Who is Solicitor ? The new tribunal for the dispensation of justice known as the Inferior Court appears to have run against a snag, owing to a conflict of authority between the two solicitors who claim the right to conduct the prosecutions in the new court. To explain the merits of the matter it will be necessary to refer to the history of this solicitorship. It may be remembered that at the last general election Mr. D. H. Chamberlain, with the thrifty design of making sure of one or the other, ran for both the office of attorney-general and the solicitorship of the First Circuit. Being elected to both these positions he chose to occupy the former and more lucrative one, leaving a vacancy in the solicitorship to be filled, according to the constitution, by the judge of the First Circuit. Judge Graham accordingly appointed Mr. E. B. Seabrook, who performed the duties and was fully recognized as the solicitor of the circuit until recently, when a charge was made, Mr. Seabrook was removed, and Mr. John G. Mackey appointed by Judge Graham in the exercise of his undisputed conslitutional authority. This was the position of affairs when the new court was opened, and the law creating the new court distinctly enacts in Section 2 that "all prosecutions shall be conducted by the attorneygeneral or the solicitor of the circuit to which the County of Charleston may be attached." Solicitor Mackey supposed that he became the prosecuting officer of the Inferior. Court, and accordingly prepared the cases that were to be brought before it, and attended its opening session in the capacity of solicitor. Judge Lee, however, appeared to take a different view of the matter, and, at the opening of the court, ignored entirely the appointments by Judge Graham, and went back to Mr. Chamberlain as the solicitor who had been elected by the people, although it is stated that he has not even qualified as solicitor, and it is certain that he has never exercised the functions of that office. The form of calling Mr. Chamberlain to act as solicitor was gone through with, and, Mr. Chamberlain not sponding, Judge Lee issued an order appoint-

ing Mr. E. B. Seabrook the solicitor pro tempore of his court, claiming to act under the same constitutional authority as was exercised by Judge Graham in his appointments. Solicitor Mackey thereupon retired from the court, after delivering the protest which was published yesterday, and took with him the papers which he had prepared for the consideration of the grand jury. These papers he turned over to the clerk of the court, by whom they were afterward delivered to Mr. Seabrook, and yesterday the court came to a stand-still, and adjourned until Monday to allow of the re-preparation of the cases. As the matter now stands, therefore, Mr. Seabrook is in fact the acting solicitor of the court, while Mr. Mackey claims to be the only officer entitled to perform the duties of that position. It is a very pretty quarrel as it stands, and may lead to some curious legal complications. If the prosecuting officer of the new court is illegally appointed, the whole of the prosecutions must be illegal and the convictions will be null and void. An excellent ground for an appeal to the Supreme Court will be presented in every case which may be tried before the new court, and writs of habeas corpus for the liberation of prisoners convicted therein may be expected to be plentiful. In the meantime, Solicitor Mackey declares his intention of exercising the right of nolle prosequi and other functions of his office, and has filed his commission with the treasury to secure his pay as solicitor. Colonel Gist appeared with his bondsmen, Messrs, A. J. Crews, L. D. Mowry and J. B. Sloan, who gave the required security, and he was released.
