Down with the Carpet-Baggers!

Surely a better time is coming—a time when every man in South Carolina shall be measured by his conduct and character, not by his glibness of tongue, or the color of his skin; when party lines shall only represent opposing theories of government, and every citizen, whichever side he esponses, shall insist that the candidates presented to him have active brains, some knowledge of public affairs, and a keen sense of honor. This is the hope in which we live; the hope which is the breath in the nostrils of the sturdy thousands who have never despaired of the Commonwealth; the "hope deferred" which shall not much longer sicken a struggling people. And why do we dare to say that the day is coming when South Carolina shall be governed with decency, with justice and with ability? We say it, because the events of the past few weeks, nay, of the past few days, indicate unerringly that the carpet-bagger is doomed, that his reign fast draws to an ignominious close.

Upon the carpet-bagger rests the respon sibility of the siege of troubles against which the white citizens struggled in vain. The carpet-bagger taught the colored man that the native white man was a Judas, who would betray the poer blacks into slavery, I they heeded his counsel or gave him their votes; that only the Puritan carpet-bagger could fitly represent the enfranchised Afri-Labor as he might, the carpet-bag ger could not fill all the comfortable berths in the ship of State; nor could his capacious gullet hold all the tid-bits which reconstruction furnished. The blacks were allowed to take a share, and the moment that they entered public life the Mephistophilean carpet bagger glided to their side. "Republican party." This is the whole history in few words It shows that some of the colored people are thinking for themselves. That speech by Stephen Brown was the death-knell of more than one carpet-bagger. The roar of ap plause with which it was received carried terror into the breasts of white adventurers, who had lived as if the negroes, body an soul, were theirs.

All that separates whites from blacks, al that makes the election of worthy public officers well-nigh impossible, is the distrust and suspicion of the native and residen whites with which the carpet-bagger has filled the mind of the credulous negro. There is no political barrier between the races. The Conservatives or Democrats recognize the binding force of the amendments to the Federal and State Constitu tions. They accept them as the suprem law of the land, and they do it sincerely and in good faith. The whole history of the fraud is printed in another column. It proves that the denial of the aflidavit was the price of the pardon. Hartranft was sinking under the weight of his misconduct, and it was hoped that a confession by Yerkes, trumped p at the eleventh hour. would save him But the trick is too plain. Radical newspapers denounce it as a brazen fraud, the tide of Liberalism is swelling, the Grant engineers will be hoist with their own petard.

In the South this plan of pardoning pliant criminals or troublesome accomplices has peen in full blast ever since reconstruction pegan. Down this way a penitentiary convict goes scot free for far less cause than in the Keystone State. There the pardon is intended to save a State. Here it is done to save a vote. The principle, however, is the same. Public morals, the suppression of crime, the holding up of examples to the potential cut-throat or cut-purse is what Mr. Toots would call "of no consequence" in comparison with the welfare of the party. Radicalism in Pennsylvania must be on its last legs, when only a pardoned convict stands between it and destruction.

"Our Dear State."

[From the Columbia Union.] The "interest" which the leaders in the bolting movement take in "our dear State" is evidenced by the taxes which have been paid by the four most prominent men in that party The tax books for Charleston County, where they all reside, show that these four gentlemen have, since 1868, a period of over four years, paid into the treasury of the State the normous (?) sum of eight hundred and sixtysix dollars and thirty-five cents, or an average of fifty-four dollars and fifteen cents each per year. Only one of the four has paid a tax every year, and the highest amount paid by him in any one year was thirty-four dollars and thirty cents. Another has paid taxes only once in four years, and that was last year; the third paid taxes for 1870 and 1871, while the fourth does not even have his name on the tax books at all, and yet he is running for the most important office in the County of Charleston. These men are the pioneers of the Bolters' movement, and are asking the people to support their crowd because they are "honest" and interested in the prosperity of the State. Bah!
