An examination of the premises reveals the fact that no violence was used in effecting an entrance into the office, and that the desk was carried out of the front door, the upper and lower bolts being unshot and the door thereupon opening. Some law books which were upon the top of the desk fell on the pavement. At a point opposite the colored cemetery, the desk was found broken open and the papers scattered in every direction. The robbers had attempted to cut off the lock, but failing in this, they so cut the door as to insert their fingers when they burst it open. Messrs Leitner & Dunlap have not missed any papers, as yet. Two sticks, a hickory and a peach, and a match-box have been found. No chips were found near the place where the desk was. Some papers were found near the corner-houses formerly owned by D. Minton. If the desk had been cut where it was found, the chips or shavings would have also been in that vicinity, so that it is clear, that desk was first cut and then carried to where it was found. Now if we had a detective here, there would be no difficulty in tracing up the parties from the clues now found.

MARKING THE TOWN LIMITS.—Mr. Colin Mc. Rae has just completed the job of surveying and marking by means of four granite pillars, the northern boundary of Camden. We understand that it is the intention of the town Council to have Mr. Mc. Rae draw a plan of the new Town, which, when completed, will be very valuable by way of reference to conveyancers of town lots. As the town now is, it extends in length, two miles and a half and somewhat over a mile in breadth. We suppose that new wards will be designated and next year the portion newly added will have representation. We see no reason why we should not be a city. We are certainly that in extent of area.

THE FREE BRIDGE.—The Special Commissioners have given the contract of building the free bridge over the Wateree River to Mr. John B. LaSalle, a distinguished architect and builder. The contract is for \$15,075.00 and is to be completed by the fifteenth of October. The plans, explanations and drawings submitted by Mr. A. Caradoue, the Civil Engineer of the So. Ca. Rail Road, were accepted. They are very complete in every particular and very nicely gotten up. Mr. LaSalle is now completing his arrangements to begin work, and soon the noise of axe, hammer and trowel will be re-echoed by the banks of the old Wateree.

Rainy weather last Sunday, prevented many persons from venturing out to Church.

CUTTING APPRAY.—On Sunday last, two colored Amazons, of whom the "green-eyed monster" had assumed corporeal control, undertook a wager of battle, whereby to decide the vexed question. One of the parties, Mary Reid, was rather severely cut, whereupon the fight ceased, and the stiffness of the Sabbath was resumed. Judge Melton may be called upon to investigate the matter at the court next week. We congratulated the Judge last week, upon having no business of consequence to transact, but certain belicose individuals, ambitious candidates for the penitentiary, may yet find something for him to do. As yet, however, we have not heard of a single case, civil or criminal, to be tried at the approaching term of the court.

INSTALLATION OF COUNCIL.—On Monday afternoon at 5 1/2 o'clock, the old Council wound up their business and was declared by the Intendant to be defunct. Trial Justice Shrock then swore in the new Council which proceeded to business.

The applications for Marshal, Inspector of Weights and Measures, and town guard were read, but on account of the lateness of the hour, the elections were deferred until next Monday.

Warden Kennedy submitted a resolution, declaring that the office of Marshal be separate from that of Recorder and Treasurer, who shall also collect town taxes, fixing the salary of Marshal at \$500.00 and of Recorder and Treasurer at \$300.00 per annum. This resolution was unanimously adopted. The Intendant made a cursory statement of the financial condition of the town, a synopsis of the policy and work of the outgoing council, and expressed the hope that the proceedings of the present, will be as harmonious and agreeable as those of the late council, which hope, we are sure, was shared by the other members of the municipal board. For the situations on the police force, four in number, there were no less than twenty-three applicants, 17 colored and six white. As a matter of course, nineteen dis appointed men will be found in town next Tuesday morning.

THREE MORE UNFORTUNATES.—Our Charleston exchanges inform us that on Friday last, true bills were found by the Grand Jury in the U. S. Court now sitting, against J. L. Leonard, John J. Chaplin and Samuel R. Latham. The crime imputed to the first two is selling toba co without proper stamps and of the latter for resisting the Assistant Assessor in discharge of this duty. This is almost a Ku Klux case. After what has happened here lately in reference to the seizure of tobacco, we think it a very grave question for our merchants to consider whether or not they will keep tobacco at all, for the law is explicit. It only requires that tobacco improperly stamped be found in the possession of a party, whether innocently or ignorantly, and the least punishment is six months imprisonment and \$500 fine; the greatest being two years imprisonment and \$2000 fine.

Besides, there is nothing given to a merchant by which he may inform himself as to whether the tobacco is properly stamped or not, and when one inquires of the officer making the seizure how he is to know, that gentleman quietly informs him that he is mum on that subject. Dont give away empty cigar or tobacco boxes without cancelling or tearing off the stamps.

This is the third burglary and the fifth attempted burglary within a week, and all five on the Main street where the police are generally supposed to be.

INCENDIARY FIRE.—THE WORKMAN BUILDING SET ON FIRE.—On Tuesday night at 10 1/2 o'clock, Mr. F. J. Oaks, Tyler of Kershaw Lodge, then holding its regular communication, happened to look across the street and discovered what he supposed to be a fire in the Elias (formerly the Workman) building. Seeing a person pass by, he called out to him to go in and see if there really was fire there. The person entering, found a fire fiercely burning, and so informed Mr. Oaks, who immediately gave the alarm, and notified the lodge where the fire was. The lodge was closed in short form, and the mem-

bers ran directly across the street, a few buckets were obtained, filled with water, which was thrown upon the fire, and in less time than it takes to write it, the fire was subdued, and soon entirely extinguished. An examination revealed the fact that fire had been set in a little wood closet just under the stairs, and the door shut in order to prevent the flames from being seen, and had not Mr. Oaks looked out at the time he did, the in all probability the fire would have obtained a good hold, and all efforts to extinguish it would have proved fruitless. This attempt was a very bold one, done in full view of the Masonic Hall, and not fifty yards from the Guard House. Mr. Oaks saw a person come out of the building a few moments before he saw the blaze, who stood at the corner of Main street until the alarm was given, when he rapidly fled. Had the fire not been extinguished when it was, nearly half of the business portion of the town would have been destroyed, as the houses are very near each other, and all wood. Messrs. Strauss and Cloud & Zemp, who occupy two of the stores in the building, and Mr. Charles Elias, for the estate of Wolf Elias, who publish a card in this issue, return thanks for the timely assistance rendered them on the occasion.—One thing is beyond question, to-wit: reform in the police department is imperatively demanded, and there is no reason why it should not be made. Here are five burglaries and one incendiary fire in little more than a week and every one immediately upon, or within a few feet of Main Street. There is no security, whatever, as to property, as the thing now stands. Council, however, is determined to rectify matters, and if competent men can be procured, they will be procured.—Each warden should be assigned a ward to patrol, and he should see that the guards do their duty. If the guards fail to discharge their duty, let them be discharged, until a competent police force is collected. The pay of the police force is a very heavy item in the expenditures of the town, and either a capable police force should be had or the entire thing abolished.
