# STATE OF SOUTH CAROLINA,

CLARENDON COUNTY. AN ELECTION WILL BE HELD at the several precincts established by law in Clarendon County, on Tuesday. November 3rd, 1896, for the following officers, to wit: Governor, Lieutenant-Governor, Secretary of State, Attorney-General, Comptroller-General, Adjutant and Inspector General, State Treasurer, State Superintendent of Education, one Railroad Commissioner, three Representatives to the Lower Branch of the Legislature, one Circuit Solicitor, one Clerk of Court, Sheriff, one Superintendent of Education, one Supervisor, one Coroner.

The polls will open at 7 o'clock a. m. and close at 4 o'clock, p. m,

At the close of the election the managers shall immediately proceed to publicly count the ballots. Within three days thereafter the Chairman of the Board of Managers, or one of them, to be designated in writing by the Board, shall deliver to the Commissioners of Election the poll list, the boxes containing the ballots, and a written statement of the result of the election at his pre-The Managers of Election shall re-

quire of every elector offering to vote at such election, before allowing him to vote, in addition to the production of his registration certificate, proof of the payment of poll tax six months before said election of any poll tax then due and payable.

The managers shall administer to the person offering to vote, an oath that he is qualified to vote at said election, according to the constitution of the State, and that he has not always voted in said election.






