COTTON CONFERENCE TO MEET IN WASHINGTON

Columbia, Dec. 5.-L. D. Jennings, of Sumter, A. R. Johnston, of St. George, and E. Wallace Evans, of Bennettsville, will * represent South Carolina Cotton Growers' Association at the national conference of commodity co-operative associations to be held in Washington, December 14, 15 and 16. All three are members of the board of directors of the South Carolina association.

The conference at Washington has been called for the purpose of forming a national organization of the forming a national ranization of the commodity marketi: g associations Judge Robert W. Bingham, of Louisville, Ky., representing the tobacco associations, will be chalrman of the meeting and Carl Williams of Oklahoma, representing the cotton assocaition, will be the vice chairman.

Representatives of the 160,000 cotton growers belonging to co-operative marketing associations will attend the conference. Delegates from five big tobacco growers' organizations that handle the sale of some two thirds of the entire crop will speak for the 200,000 members of those or-Representatives from ganizations. something like 15 states wheat growers' organizations will be in attendance. Dairy producers' organizations from the Atlantic to the Pacific, orange growers from the west to the east, vegetable and melon growers' organizations from every district in the country, the producers of California dried fruits, the co-operative poultrymen and members of numerous other co-operative associations will be represented.

More than \$1,000,000,000 worth of farm products, it is estimated, will be marketed by co-operative associations this year. Among these products are cotton, tobacco, alfalfa, wheat, peanuts, milk, eggs, fruits, maple, sugar, raisins, prunes, rice, tomatoes, livestock and many others.

The South Carolina delegates will be able to report tremendous growth of the co-operative marketing idea in this state. The South Carolina Cotton Growers' Co-operative association is making its debut this season in a manner that is said to be very gratifying to its entire membership and to the bankers and business men of the State. The Tri-State Tobacco Growers' association comprising the tobacco growers of North and South Carolina and Virginia, made its debut this year and the morale of its membership is said to be 10 Oper cent.

The South Carolina Cotton Gorwers' Co-operative association was formally organized June 16, with a membership of approximately 9,000. Over 2,000 members have been added since that time, giving it a membership today of over 11,000. Many of these members have been added since the opening of the cotton season and were secured as result of very genearl satisfaction with the operations of the association.


