L. P. Mitchell, acting comptroller of the treasury, has rendered a decision of the question of the reimbursement of governors of States and territories for costs and expenses which may have incurred in aiding the United States to raise a volunteer army. He holds that the governors may be reimbursed for reasonable costs incurred before the acceptance of the troops into the service of the United States.
