**Railroad Commission Wishes to Know Status of Northwestern Road.**

The following appeared in the Columbia Record of last Monday:

The question of whether or not the Northwestern Railroad of South Carolina and the Atlantic Coast Line Railway company are under the same ownership will be again by the railroad commission at a hearing to be held in Sumter on May 5. The Northwestern is the road running from Sumter to Camden and from Sumter to Wiles Mill and Simmon's. The present head of the road is Thomas Wilson.

The petition to require the Coast Line and the Northwestern to operate a continuous mileage base of freight rates is from the Camden chamber of commerce. At present the combination of roads less than 20 per cent is the basis.

Should it be shown that the two roads are jointly owned the continuous mileage base will be ordered by the commission. This was done in the commission in the case of the Coast Line and the Charleston & Western Carolina and in the case of the Chesterfield & Lancaster and the Seaboard.

## ORDINANCE.

### SPECIAL LICENSE.

Be it ordained by the Mayor and Aldermen of the City of Camden, S. C., and by the authority of the same:

See, I. That this Special License Ordinance adopted by the City of Camden on the 3rd day of April, 1911, for the present fiscal year, and passed and ordained as a special ordinance to raise supplies for the fiscal year ending April 30th, 1912. That every person, firm or corporation, engaged or intending to engage in any trade, business or profession hereafter mentioned, within the limits of the City of Camden, shall first obtain a license from the Clerk and Treasurer, and all licenses herein mentioned shall be non-transferable and for the fiscal year, if not otherwise specially provided. And all annual licenses shall expire on April 30th, 1912, but may be revoked at any time by the Mayor or City Council.

See, II. All licenses for the year granted under this Ordinance shall continue in force until the 30th day of April next, exceeding the date of issuance, and no license, except as provided for by limitation, per diem or month, shall be issued for less time or than one year. The City Clerk and Treasurer shall prepare a proper license to be issued in each case.

See III. Applications for license of all kinds shall be made to the City

Clerk and Treasurer, and all fees for same shall be paid to him in advance.	Merchandise, per day.	60 00

No person, firm or corporation engaged in, prosecute or carry on any business, occupation or profession, hereinafter mentioned without first receiving from the Clerk and Treasurer of the City, a special license therefor. Any person or persons, corporations or associations, failing to secure such license shall, on conviction, be fined not less than \$50 five dollars, or more than \$100, one hundred dollars, or imprisonment not more than 30 days in the discretion of the Recorder.
